

PARCEL 1: A parcel of land located in the Southwest  $\frac{1}{4}$  of Section 27, T2N, R15E, Village of Darien, Walworth County, Wisconsin, described as follows: Commencing at the intersection of the Southwesterly line of U.S. Highway 14 with the centerline of Peters Road; thence S0°08'00"W, along said centerline, 320.35 feet; thence N70°01'00"W, 181.63 feet to the place of beginning; thence N63°02'00"W, 207.36 feet; thence N44°13'00"E, 50.00 feet; thence S69°13'30"E, 157.82 feet; thence S1°52'30"E, 74.00 feet to the place of beginning.

PARCEL 2: A parcel of land located in the Southwest  $\frac{1}{4}$  of Section 27, T2N, R15E, Village of Darien, Walworth County, Wisconsin, described as follows: Commencing at the intersection of the Southwesterly line of U. S. Highway 14 with the centerline of Peters Road; thence S0°08'00"W along said centerline, 320.35 feet to the place of beginning; thence continue S0°08'00"W along said centerline, 11.65 feet; thence N66°37'00"W, 185.90 feet; thence S70°01'00"E, 181.63 feet to the place of beginning.


PARCEL 3: A parcel of land located in the Southwest  $\frac{1}{4}$  of Section 27, T2N, R15E, Village of Darien, Walworth County, Wisconsin, described as follows: Commencing at the intersection of the Southwesterly line of U. S. Highway 14 with the centerline of Peters Road; thence S0°08'00"W along said centerline 404.99 feet; thence N71°18'00"W, 148.94 feet to the place of beginning; thence continue N71°18'00"W, 114.10 feet; thence N60°52'00"W, 298.38 feet; thence S63°43'00"E, 411.43 feet to the place of beginning.

COMBINATION OF PARCELS 2, 3, AND 4: A parcel of land located in the Southwest  $\frac{1}{4}$  of Section 27, T2N, R15E, Village of Darien, Walworth County, Wisconsin, described as follows: Commencing at the intersection of the Southwesterly line of U. S. Highway No. 14 with the centerline of Peters Road; thence S0°08'00"W along said centerline, 320.35 feet to the place of beginning; thence continue S0°08'00"W along said centerline, 84.64 feet; thence N71°18'00"W, 148.94 feet; thence N60°52'00"W, 298.38 feet; thence N44°13'00"E, 66.55 feet; thence S63°02'00"E, 207.36 feet; thence S70°01'00"E, 181.63 feet to the place of beginning.
