

TWO PARCELS OF LAND LOCATED IN THE SOUTH 1/2 OF SECTION 18 AND IN THE NORTH 1/2 OF SECTION 19, T2N, R16E, CITY OF DELAVAN, WALWORTH COUNTY, WISCONSIN AND DESCRIBED AS FOLLOWS:

COMMENCING AT THE INTERSECTION OF THE WEST LINE OF SOUTH SECOND STREET AND THE WESTERLY EXTENSION OF THE NORTH LINE OF PHOENIX STREET IN SAID CITY OF DELAVAN; THENCE S 0°04'10" E 154.53 FEET ALONG THE WEST LINE OF SAID SOUTH SECOND STREET TO AN IRON PIPE; THENCE CONTINUE S 0°04'10" E 66.00.

FEET ALONG THE WEST LINE OF SAID SOUTH SECOND STREET TO AN IRON PIPE AND THE PLACE OF BEGINNING;

THENCE CONTINUE S 0°04'10" E 60.00 FEET ALONG THE WEST LINE OF SAID SOUTH SECOND STREET; THENCE


S 89°59'25" W 117.00 FEET TO AN IRON ROD; THENCE N 53°07'30" W 59.97 FEET TO A NAIL SET IN THE

BASE OF A TREE; THENCE N 0°06'45" W 24.00 FEET TO AN IRON PIPE; THENCE N 89°59'25" E 164.95 FEET

TO AN IRON PIPE ON THE WEST LINE OF SAID SOUTH SECOND STREET AND THE PLACE OF PECLANIAGE CONTAINS. TO AN IRON PIPE ON THE WEST LINE OF SAID SOUTH SECOND STREET AND THE PLACE OF BEGINNING, CONTAINING 0.21 ACRES MORE OR LESS. THIS IS A LOT LINE ADJUSTMENT.

PARCEL TWO COMMENCING AT THE INTERSECTION OF THE WEST LINE OF SOUTH SECOND STREET AND THE WESTERLY EXTENSION OF THE NORTH LINE OF PHOENIX STREET IN SAID CITY OF DELAVAN; THENCE S 0°04'10" E 154.53 FEET ALONG THE WEST LINE OF SAID SOUTH SECOND STREET TO AN IRON PIPE AND THE PLACE OF BEGINNING; THENCE CONTINUE S 0°04'10" E 126.00 FEET ALONG THE WEST LINE OF SAID SOUTH SECOND STREET; THENCE S 89° 59'25" W 8.25 FEET TO AN IRON ROD; THENCE N 0°04'10" W 126.00 FEET ALONG A LINE PARALLEL WITH THE WEST LINE OF SAID SOUTH SECOND STREET TO AN IRON ROD; THENCE N 89°59'25" E 8.25 FEET TO AN IRON PIPE ON THE WEST LINE OF SAID SOUTH SECOND STREET AND THE PLACE OF BEGINNING, CONTAINING 0.02 ACRES MORE OR LESS. THIS IS A LOT LINE ADJUSTMENT.

NOTE: THE BEARING ON THE WEST LINE OF SOUTH SECOND STREET IS ASSUMED S 0°04' 10" E AS SHOWN ON EXISTING SURVEY RECORDS.
