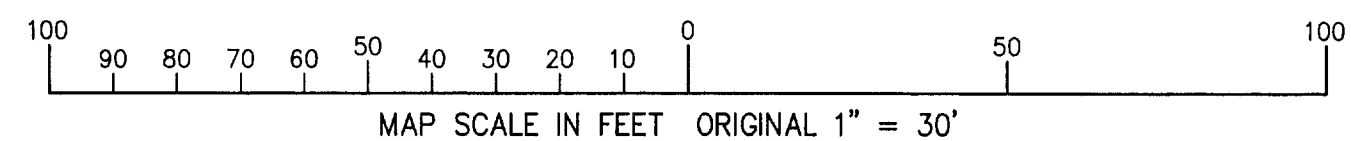

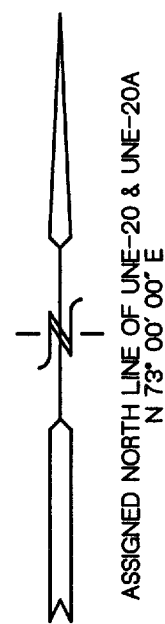
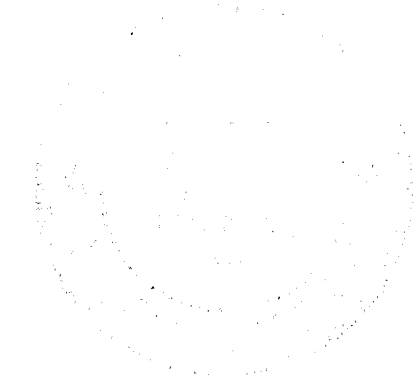
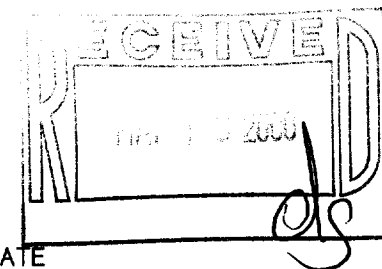
A PARCEL OF LAND SIX (6) FEET IN WIDTH LOCATED IN THE SOUTHWEST 1/4 OF SECTION 31, TOWN 3 NORTH, RANGE 17 EAST, CITY OF ELKHORN, WALWORTH COUNTY, WISCONSIN, CURRENTLY PART OF TAX PARCEL UNE-19 TO BECOME PART OF TAX PARCEL UNE-20A, MORE PARTICULARLY DESCRIBED AS FOLLOWS: COMMENCING AT AN IRON PIPE STAKE FOUND MARKING A POINT 763.7 FEET SOUTH AND 271 FEET EAST OF THE NORTHWEST CORNER OF ROCKWELL'S ADDITION TO THE CITY OF ELKHORN; THENCE S 23DEG 38MIN 47SEC E, 100.00 FEET; THENCE S 73DEG 00MIN 00SEC W, 213.50 FEET TO AN IRON PIPE STAKE; THENCE S 42DEG 02MIN 21SEC E, 202.84 FEET TO THE POINT OF BEGINNING; THENCE CONTINUE S 42DEG 02MIN 21SEC E, 87.00 FEET TO AN IRON PIPE STAKE FOUND LYING ON THE NORTHERLY RIGHT OF WAY LINE OF STATE TRUNK HIGHWAY "H"; THENCE ALONG SAID RIGHT OF WAY, S 42DEG 10MIN 26SEC W, 6.03 FEET; THENCE N 42DEG 02MIN 21SEC W, 87.00 FEET; THENCE N 42DEG 10SEC 26SEC E, 6.03 FEET TO THE POINT OF BEGINNING. CONTAINING 522 SQUARE FEET (0.01 ACRES) OF LAND, MORE OR LESS.
