

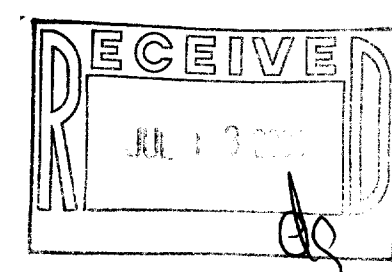


PLAT OF SURVEY LOT 24 OF PHEASANT RIDGE

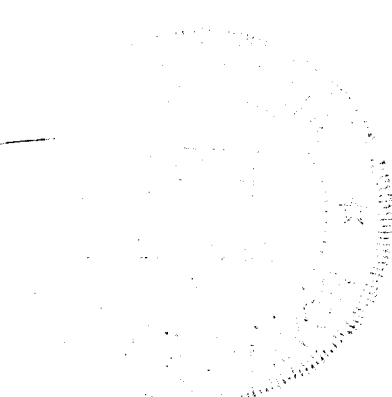

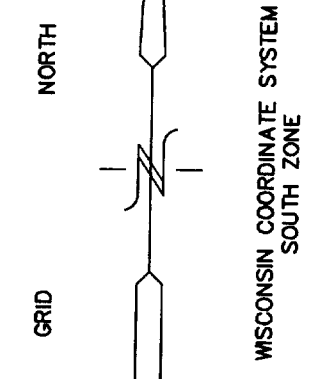

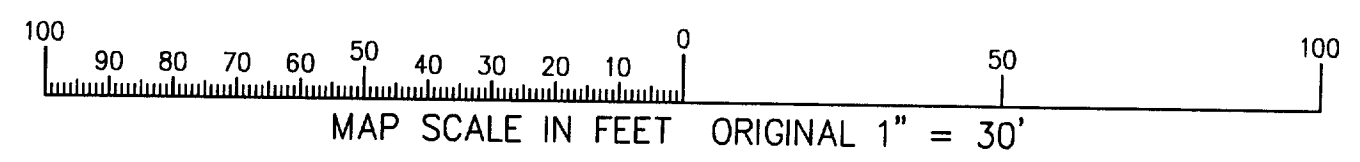
