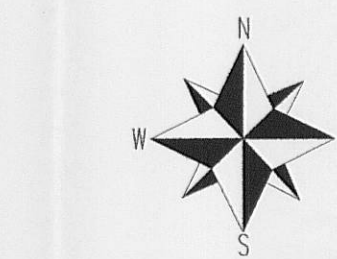
PARCEL 1:
THE NORTHEASTERLY 35 FEET (MEASURED ON THE EASTERLY LINE OF LAKE AVENUE) OF THE FOLLOWING DESCRIBED PROPERTY: BEGINNING AT A CONCRETE MONUMENT ON THE EASTERLY SIDE OF LAKE AVENUE AND BEING THE SOUTHWEST CORNER OF LOT 1 IN BLOCK 1 OF D.A. REID'S ADDITION TO REID'S PARK AFORESAID; THENCE NORTHEASTERLY ON SAID EASTERLY LINE OF LAKE AVENUE, 51.3 FEET TO AN IRON PIPE; THENCE CONTINUING NORTHEASTERLY ON SAID EASTERLY LINE OF LAKE AVENUE 14.13 FEET; THENCE EASTERLY 3.62 FEET TO A CONCRETE MONUMENT; THENCE CONTINUING EASTERLY ON THE SAME COURSE 18.94 FEET TO A CONCRETE MONUMENT; THENCE CONTINUING EASTERLY ON THE SAME COURSE 12 FEET MORE OR LESS TO THE SHORE LINE OF GENEVA LAKE; THENCE SOUTHERLY ALONG THE SHORE LINE OF GENEVA LAKE TO A POINT 31.69 FEET EASTERLY OF THE POINT OF BEGINNING; THENCE WESTERLY 12 FEET TO A CONCRETE MONUMENT; THENCE CONTINUING ON THE SAME COURSE WESTERLY 19.69 FEET TO THE POINT OF BEGINNING, ALL IN WALWORTH COUNTY, WISCONSIN.

PARCEL 2:
THE NORTH 20 FEET OF LOT 1 AND THE SOUTH 30.43 FEET OF LOT 1 EXCEPT THE SOUTH 15 FEET THEREOF IN BLOCK 1 OF D.A. REID'S ADDITION TO REID'S PARK, FONTANA-ON-GENEVA LAKE, IN WALWORTH COUNTY, WISCONSIN.
THE ABOVE LAND DESCRIBED BY SURVEYS OF ROBERTS & FISCHER INC., SURVEYORS, DATED JULY 30, 1970 AS FOLLOWS: BEGINNING ON THE EAST LINE OF LAKE AVENUE AT THE NORTHWEST CORNER OF BLOCK 1 THENCE SOUTHERLY ALONG THE EAST LINE OF LAKE AVENUE, 20.08 FEET, TO AN OAK TREE, THENCE EASTERLY 30.93 FEET TO THE LAKE SHORE, THENCE NORTHERLY ALONG THE LAKE SHORE 20.1 FEET TO THE NORTH-EAST CORNER OF LOT 1 BLOCK 1 OF SAID REID'S ADDITION TO REID'S PARK, THENCE WESTERLY ALONG THE NORTH LINE OF SAID LOT 1 BLOCK 1, 30.9 FEET MORE OR LESS TO THE PLACE OF BEGINNING, ALSO BEGINNING AT AN IRON PIPE 15.45 FEET NORTHEASTERLY OF THE SOUTHWEST CORNER OF LOT 1 BLOCK 1 SAID REID'S ADDITION TO REID'S PARK, THENCE NORTHEASTERLY ALONG THE EAST LINE OF LAKE AVENUE, 14.95 FEET THENCE EASTERLY TO THE LAKE SHORE 33.58 FEET MORE OR LESS THENCE SOUTHERLY ALONG THE LAKE SHORE 14.5 FEET; THENCE WESTERLY 30.91 FEET MORE OR LESS TO THE PLACE OF BEGINNING.

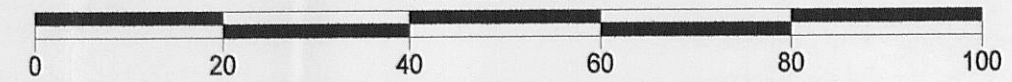

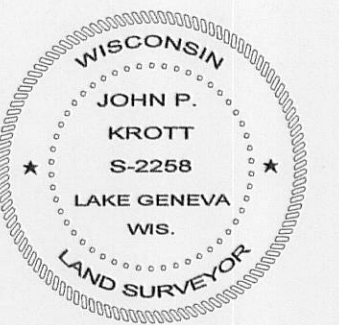
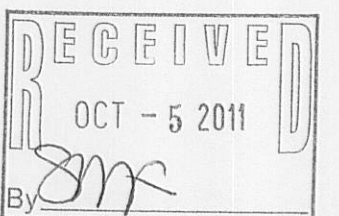
