

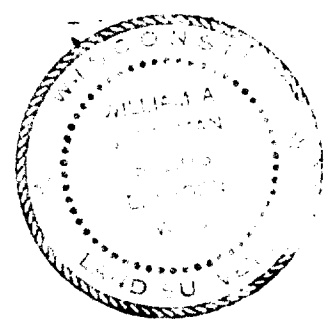
DESCRIPTION

Commencing at the West 1/4 corner of said Section 15-1-16; thence East along the East-West 1/4 Section line 1323.78 feet to the point of beginning; thence N 0°34'51"W, 660.24 feet; thence S 89°58'09"E, 1270.38 feet to the Easterly line of the former railroad right-of-way at the Lake Geneva and Lake Delavan Electric Company; thence S 10°18'25"W, along the Easterly line of said right-of-way, 18.29 feet; thence S 10°18'25"W along the Easterly line of said right-of-way 162.68 feet; thence S 13°00'34"W along the Easterly line of said right-of-way 226.00 feet; thence S 89°50'27"W 182.21 feet; thence S 0°04'24"E, 260.77 feet to the East-West 1/4 Section line of said Section 15; thence West 166.39 feet; thence N 0°08'08"W, 260.57 feet; thence S 89°58'08"W, 167.00 feet; thence S 0°12'54"E, 260.48 feet to the East-West 1/4 Section line of said Section 15; thence West along East-West 1/4 Section line of said Section 15, 665.52 feet to the point of beginning, containing 16.247 acres more or less.

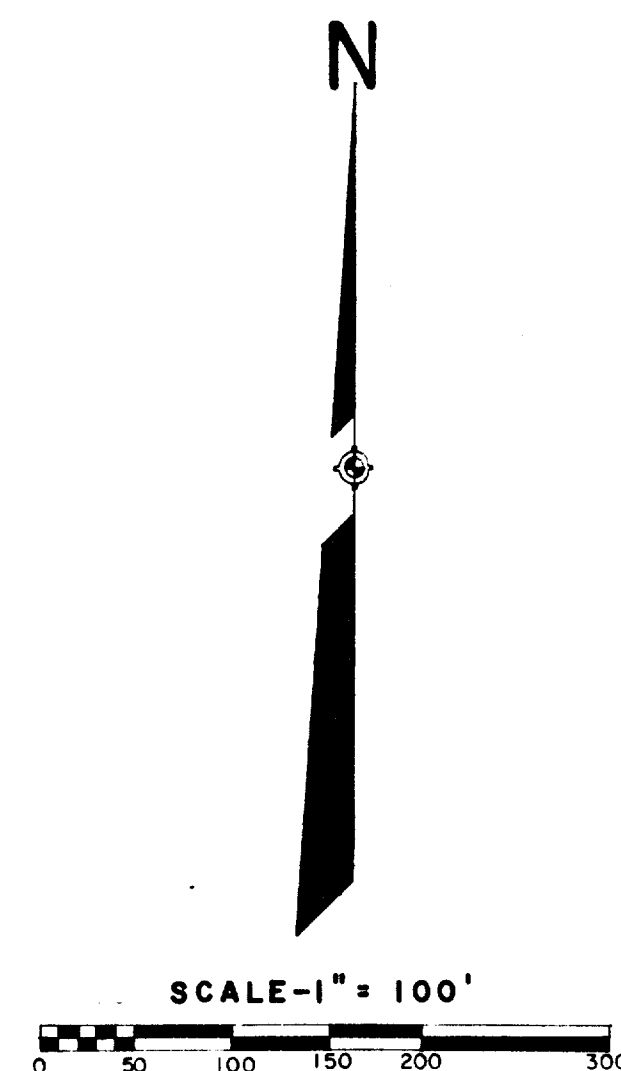
