












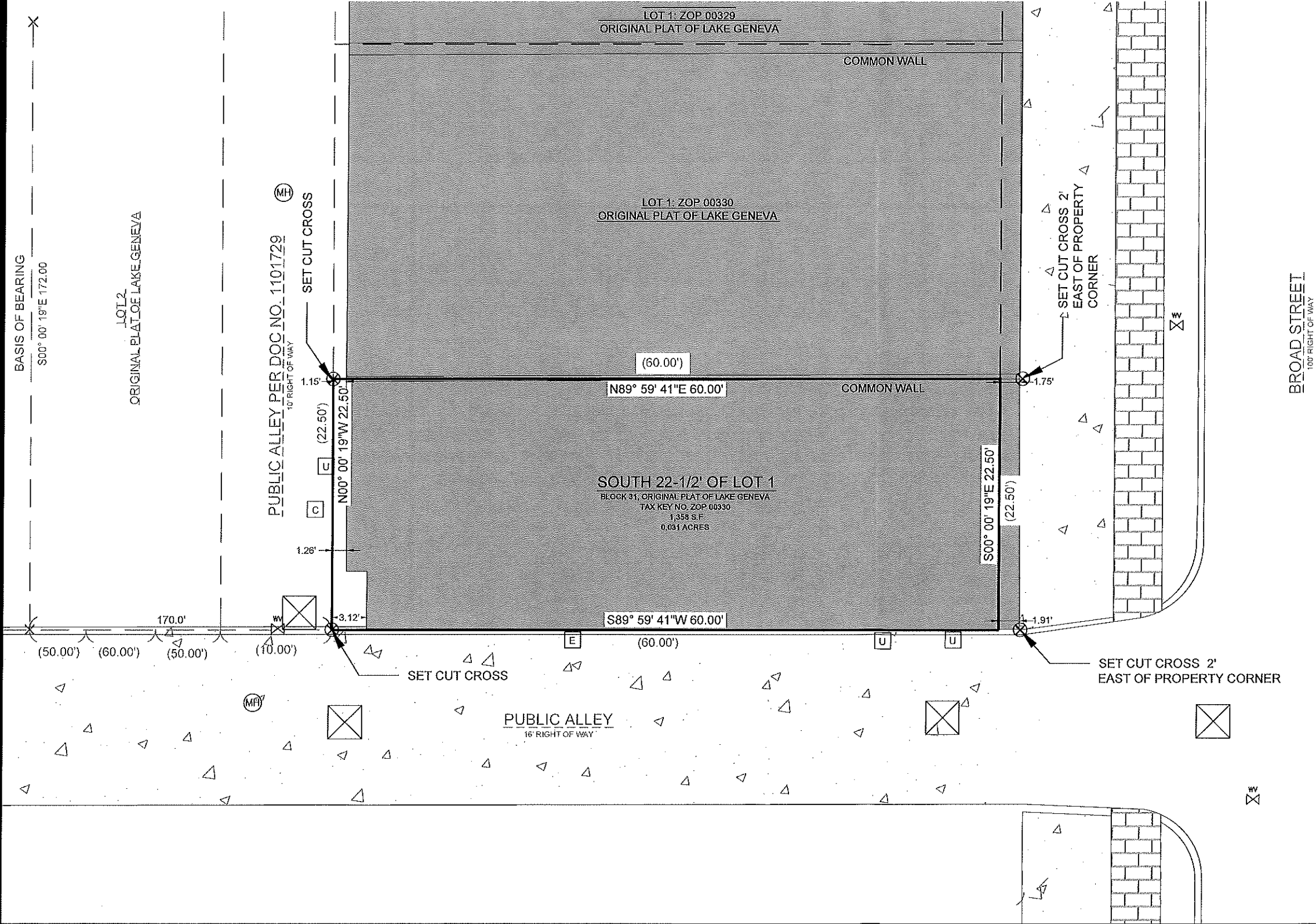
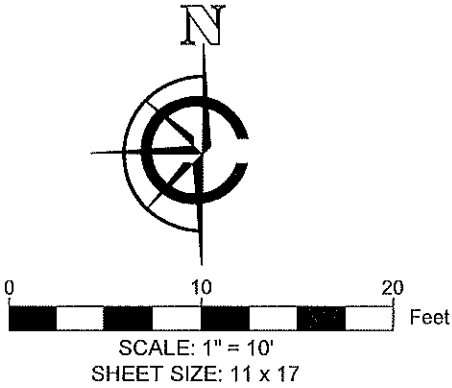


PLAT OF SURVEY
