Measured south on West line Lake
View Ave. from Orchard Lane 65'
and 1' west of walk and 116' West
from L.V. Ave. point and 65.2'
South from west point on Orchard
Lane and set iron stk. Measured
South on E. line from iron Orchard
Lane 114.4' to a light pole at S.E.
Cor. of Lot 12 and found iron
stk at pole a little east of pole
measured west Orchard Ave line
40.6' thence S.W. 38.1' and found
iron stk. thence nearly South
70' and checked over to S and

of East line 100' and found
the west end of East line was
16' east of curb on Wood Drive
Set stakes at all cots and 1 at
intersections of North line at
S.E. at pole, S.W. at pole
and one at Lake Wood
Drive at each end of 70' line
iron and tall wood at all points
and one in the lot showing
number of lot and Block.
Junc. of Orchard & Lake Wood
is given a much wider terrace
than recorded.
