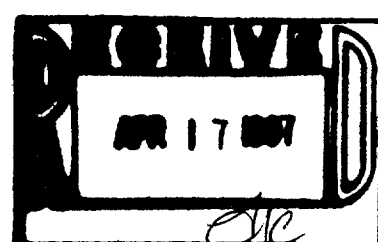
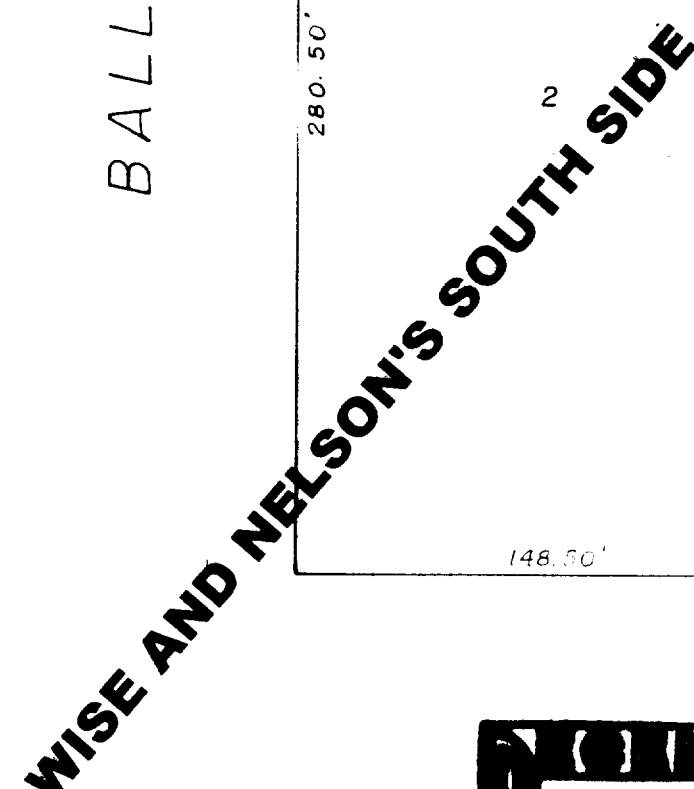


PARCEL B: LOTS 3, 4 AND 5 IN BLOCK 4 AND LOTS 1 AND 2 IN BLOCK 5, AND THAT PART OF LOTS 3 AND 4, BLOCK 5, LYING SOUTHWESTERLY OF A LINE BEGINNING 1 1/2 RODS NORTH OF THE SOUTHWEST CORNER OF LOT 4, BLOCK 5, THENCE RUNNING SOUTHEASTERLY ACROSS LOTS 4 AND 3 AND FORMER DOUGLASS STREET, NOW VACATED, TO A POINT 1 1/2 RODS SOUTH OF THE NORTHWEST CORNER OF LOT 3, BLOCK 6, ALL IN BRIGHAM'S ADDITION TO THE VILLAGE OF SHARON, TOGETHER WITH A PARCEL OF LAND ADJOINING SAID LOTS IN SAID BLOCKS DESCRIBED AS THE WEST 1/2 OF FORMER DOUGLASS STREET, NOW VACATED, AND BEING BOUNDED ON THE SOUTH BY THE SOUTH LINE OF LOT 3, BLOCK 4 EXTENDED EAST AND ON THE NORTH BY A LINE EXTENDING EAST FROM THE POINT OF INTERSECTION OF THE EAST LINES OF LOTS 2 AND 3, BLOCK 5, WITH A LINE BEGINNING 1 1/2 RODS NORTH OF THE SOUTHWEST CORNER OF LOT 4, BLOCK 5, AND RUNNING THENCE SOUTHEASTERLY ACROSS LOTS 4 AND 3, AND FORMER DOUGLASS STREET, NOW VACATED, TO A POINT 1 1/2 RODS SOUTH OF THE NORTHWEST CORNER OF LOT 3, BLOCK 6, ALL IN BRIGHAM'S ADDITION TO THE VILLAGE OF SHARON.
