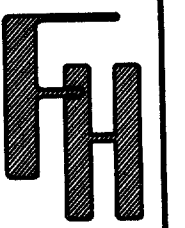


PLAT OF SURVEY LOT 38 OF BLOCK 3 LAKEWOOD TRAILS SUBDIVISION

WALWORTH COUNTY, WISCONSIN



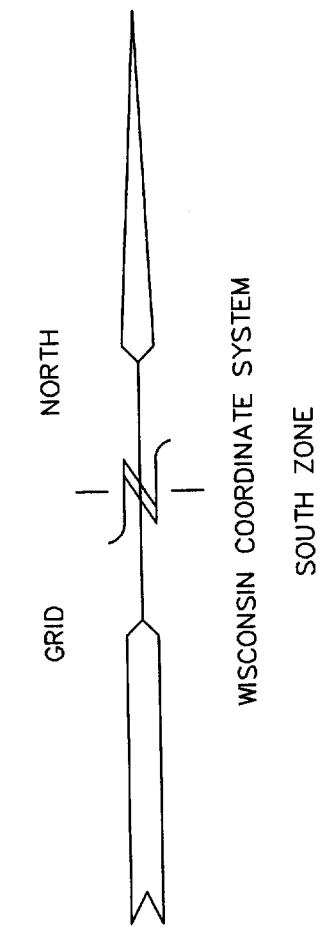
