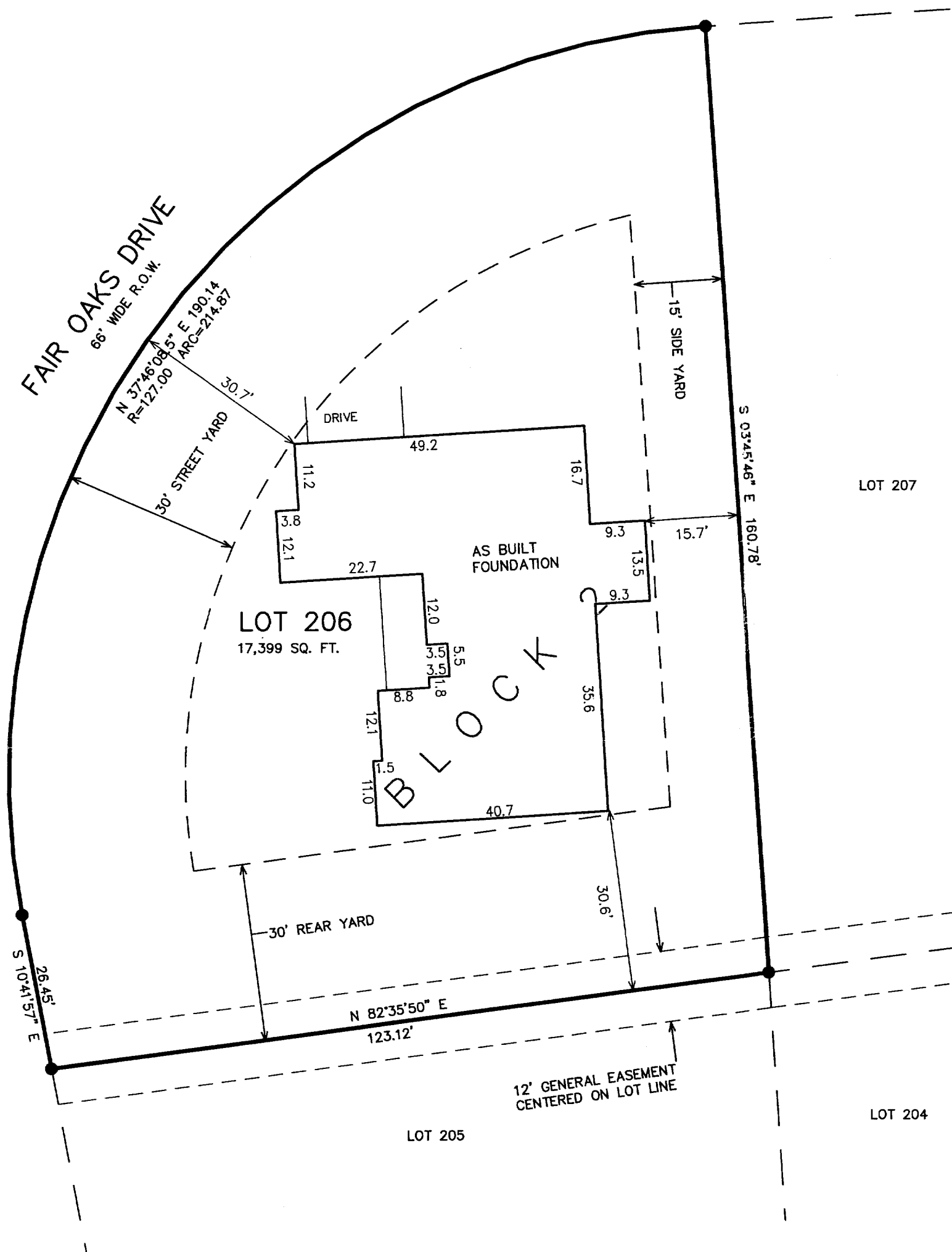


PLAT OF SURVEY LOT 206 OF BLOCK 2 LAKEWOOD TRAILS NORTH SUBDIVISION

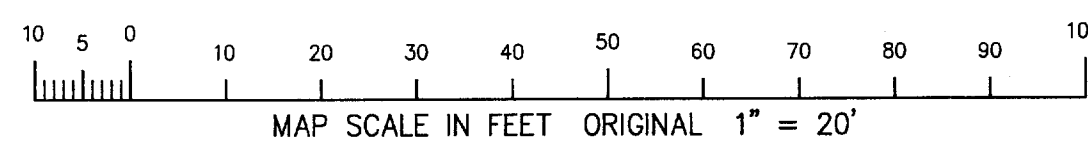
