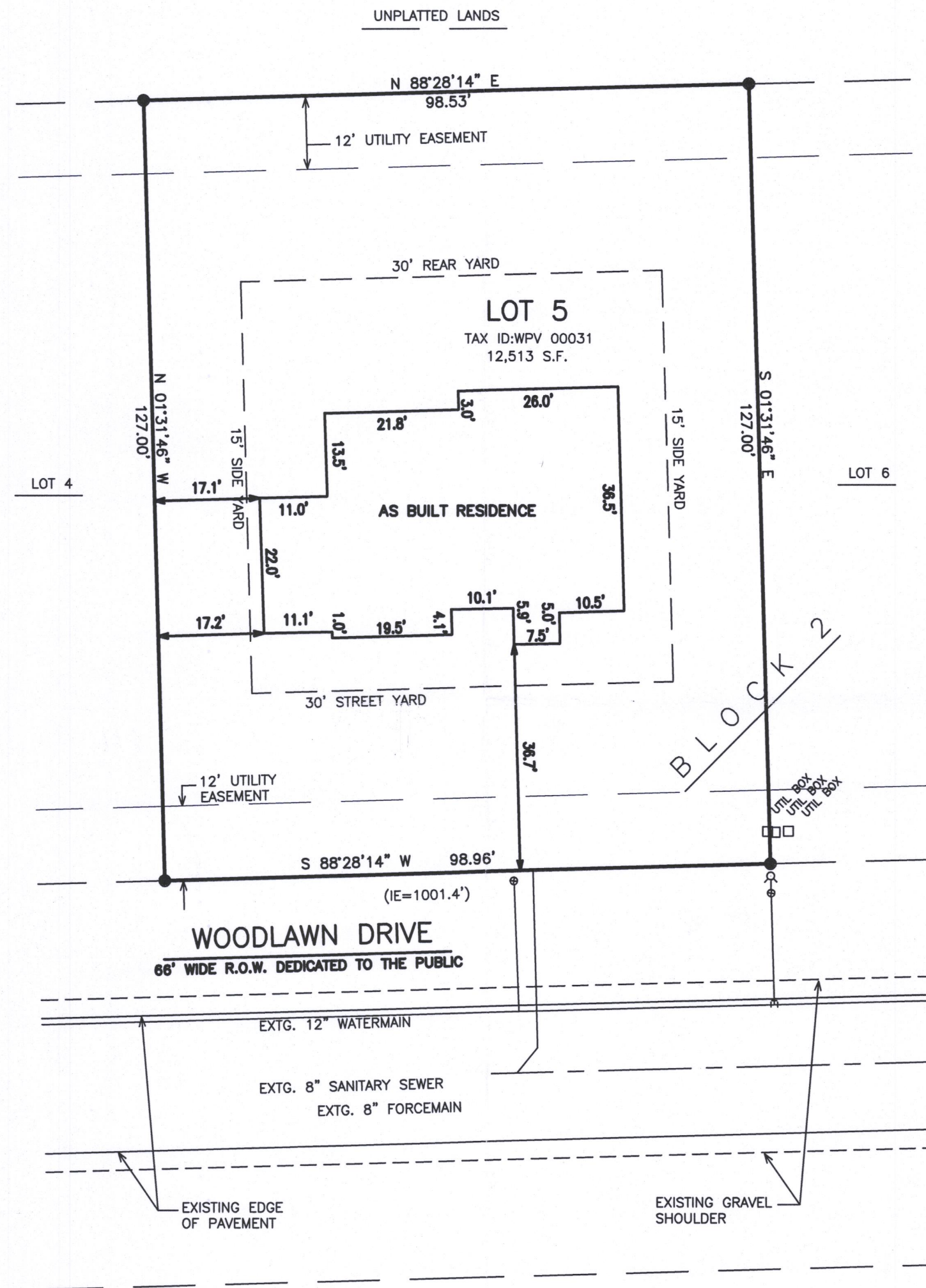

WALWORTH COUNTY, WISCONSIN

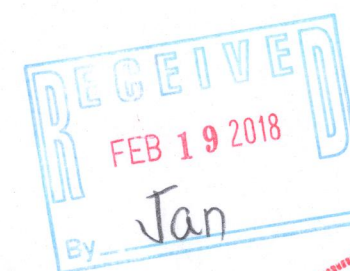
