LEGAL DESCRIPTION ACCESS & EGRESS EASEMENT

AN EASEMENT FOR ACCESS AND EGRESS OVER THE FOLLOWING DESCRIBED LANDS TO BECOME APPURTENANT TO THE EXISTING ACCESS EASEMENT OF RECORD. SAID EASEMENT IS A PART OF LOT 5 OF ANGELS FLIGHT SUBDIVISION, THE ADDITIONAL EASEMENT AREA BEING ADDED TO ALLOW FOR THE DRIVEWAY AS CONSTRUCTED TO BE WITHIN AN EASEMENT AREA. COMMENCING AT THE NORTHWEST CORNER OF LOT 5 OF SAID ANGELS FLIGHT SUBDIVISION; THENCE S 39DEG 31MIN 32SEC E, 70.00 FEET ALONG THE EAST LINE OF SAID LOT 5 TO THE POINT OF BEGINNING IN THE NORTHERLY LINE OF THE EXISTING ACCESS EASEMENT AS SHOWN ON THE RECORD PLAT FOR ANGELS FLIGHT SUBDIVISION; THENCE N 39DEG 31MIN 32SEC W, 20.00 FEET; THENCE 58.48 FEET ALONG THE ARC OF A CURVE TO THE RIGHT HAVING A RADIUS OF 90.39 FEET AND A CHORD WHICH BEARS S 80DEG 03MIN 17SEC W, 57.46 FEET TO THE EXISTING ACCESS EASEMENT; THENCE ALONG SAID EASEMENT 76.91 FEET ALONG THE ARC OF A CURVE TO THE LEFT HAVING A RADIUS OF 50.00 FEET AND A CHORD WHICH BEARS S 85DEG 27MIN 43SEC E, 69.55 FEET TO THE POINT OF BEGINNING.

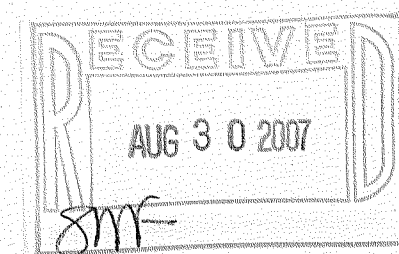

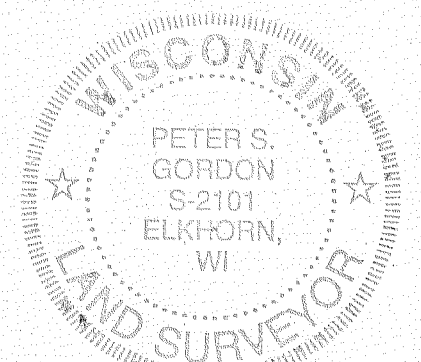
