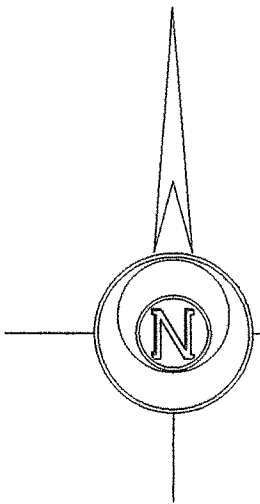
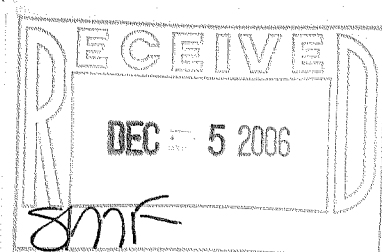


Plat of Survey

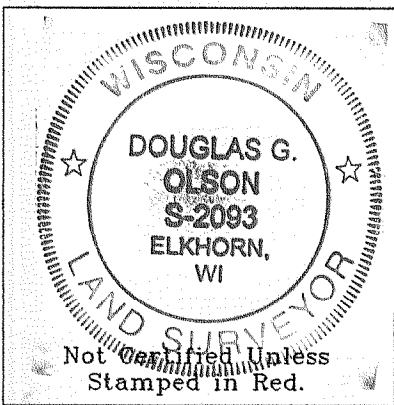

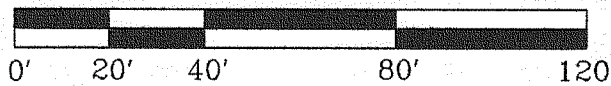
