R 16 E WALWORTH COUNTY, WISCONSIN, DESCRIBED AS FOLLOWS: BEGINNING AT THE SOUTHEAST CORNER OF SAID LOT 1; THENCE N31°44'W ALONG THE LINE OF SSAID LOT 1, 300.32 FEET TO AN IRON PIPE; THENCE CONTINUE ON THE SAME COURSE 11.0 FEET TO THE SHORE OF DELEVAN LAKE; THENCE SOUTHWESTERLY ALONG THE SHORE OF DELEVAN LAKE 101.5 FEET MORE OR LESS TO A POINT; THENCE S36°27'E 16.0 FEET MORE OR LESS TO AN IRON PIPE THAT IS LOCATED S67°01'W 100.00 FEET FROM THE LAST MENTIONED IRON PIPE; THENCE CONTINUE S36°27'E 120.36 FEET TO AN IRON PIPE; THENCE S 45°43'E 195.83 FEET TO THE NORTHERLY LINE OF SOUTH SHORE DRIVE AND WHICH LINE IS ALSO THE SOUTHERLY LINE OF SAID LOT 1; THENCE NORTHEASTERLY ALONG THE LOT LINE 41.98 FEET TO THE PLACE OF BEGINNING.

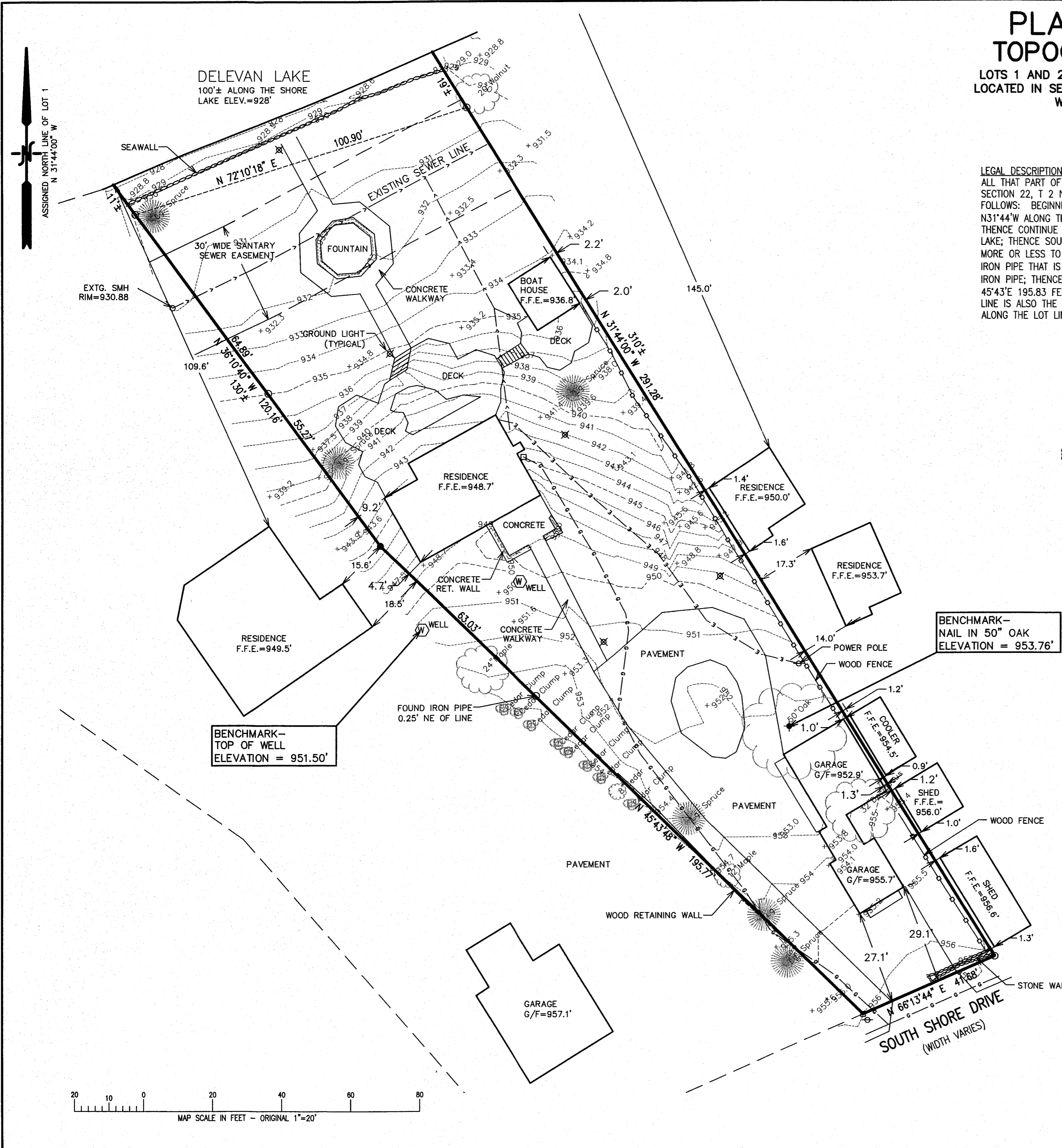

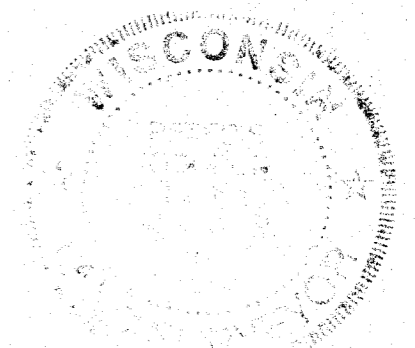

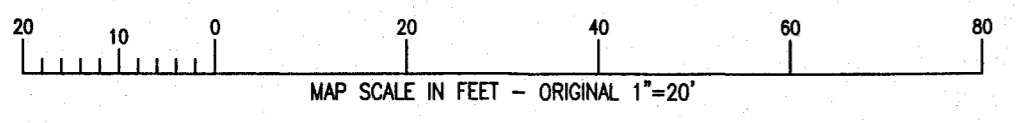
