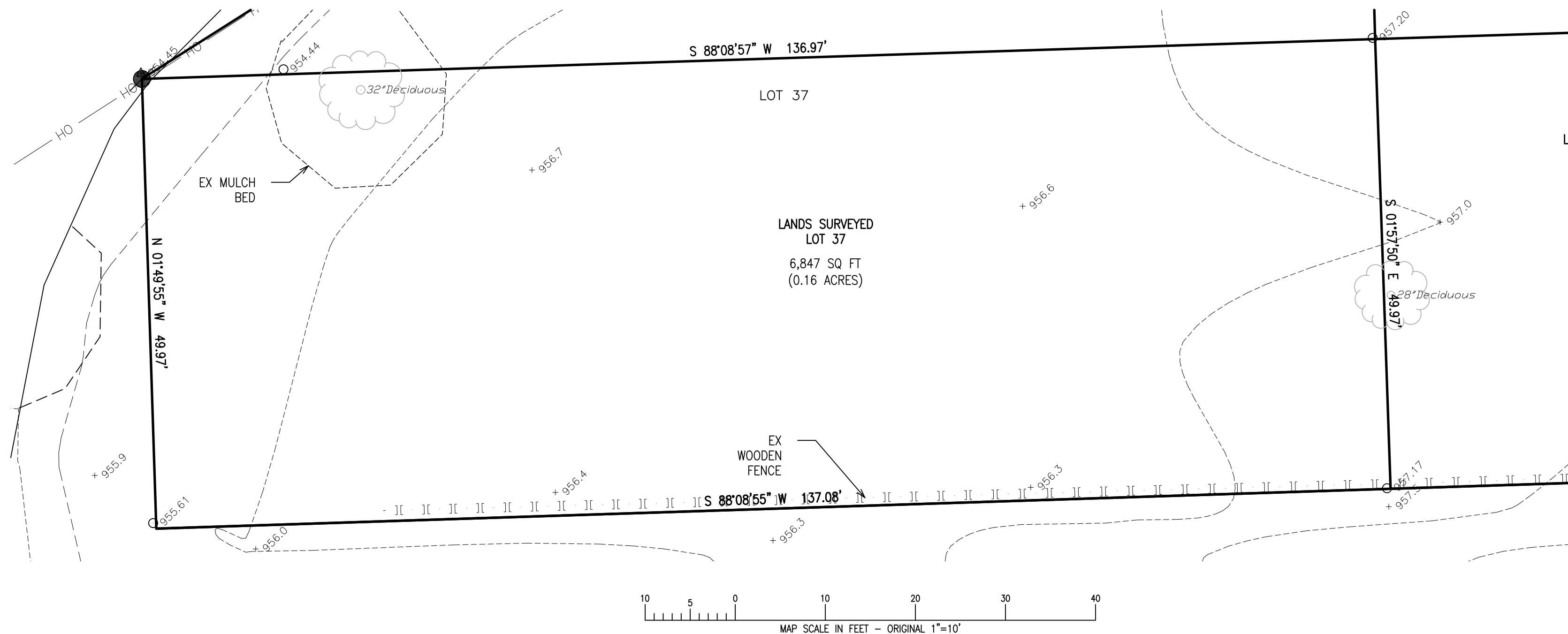
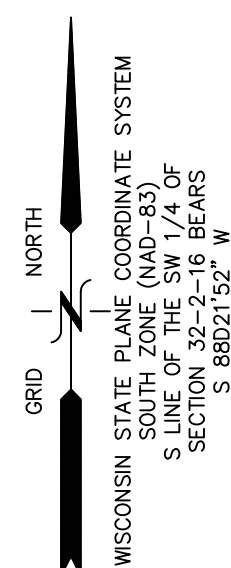


PLAT OF SURVEY LOTS 37 OF LAKE VIEW SUBDIVISION DELAVAN

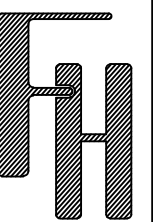
