

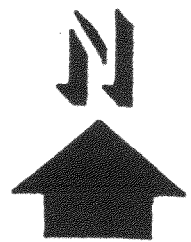
PLAT OF SURVEY OF

TOWNSHIP OF DELAVAN, DESCRIBED AS FOLLOWS: BEGINNING AT THE SOUTHWEST CORNER OF THE NORTHEASTERLY 1/2 OF SAID LOT 5, THENCE NORTHEASTERLY ALONG THE SOUTHEASTERLY LINE OF SAID LOT 5, 20.74 FEET; THENCE NORTHEASTERLY PARALLEL WITH THE SOUTHWESTERLY LINE OF SAID NORTHEASTERLY 1/2 OF LOT 5, 257.28 FEET; THENCE NORTHEASTERLY AT RIGHT ANGLES TO THE AFOREMENTIONED LINE 96.00 FEET; THENCE NORTHEASTERLY PARALLEL WITH AND 116.00 FEET NORTHEASTERLY OF THE SOUTHWESTERLY LINE OF THE NORTHEASTERLY 1/2 OF LOT 5, 124.50 FEET TO THE SHORE OF DELAVAN LAKE; THENCE SOUTHWESTERLY ALONG THE SHORE OF DELAVAN LAKE 116.32 FEET MORE OR LESS TO THE NORTHEAST CORNER OF THE NORTHEAST LINE OF LOT 5; THENCE SOUTHWESTERLY ALONG THE SOUTHWESTERLY LINE OF THE NORTHEAST 1/2 OF LOT 5, 254.30 FEET TO THE PLACE OF BEGINNING.

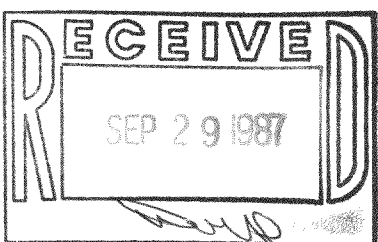
CERTIFIED SURVEY MAP NO. 1179
