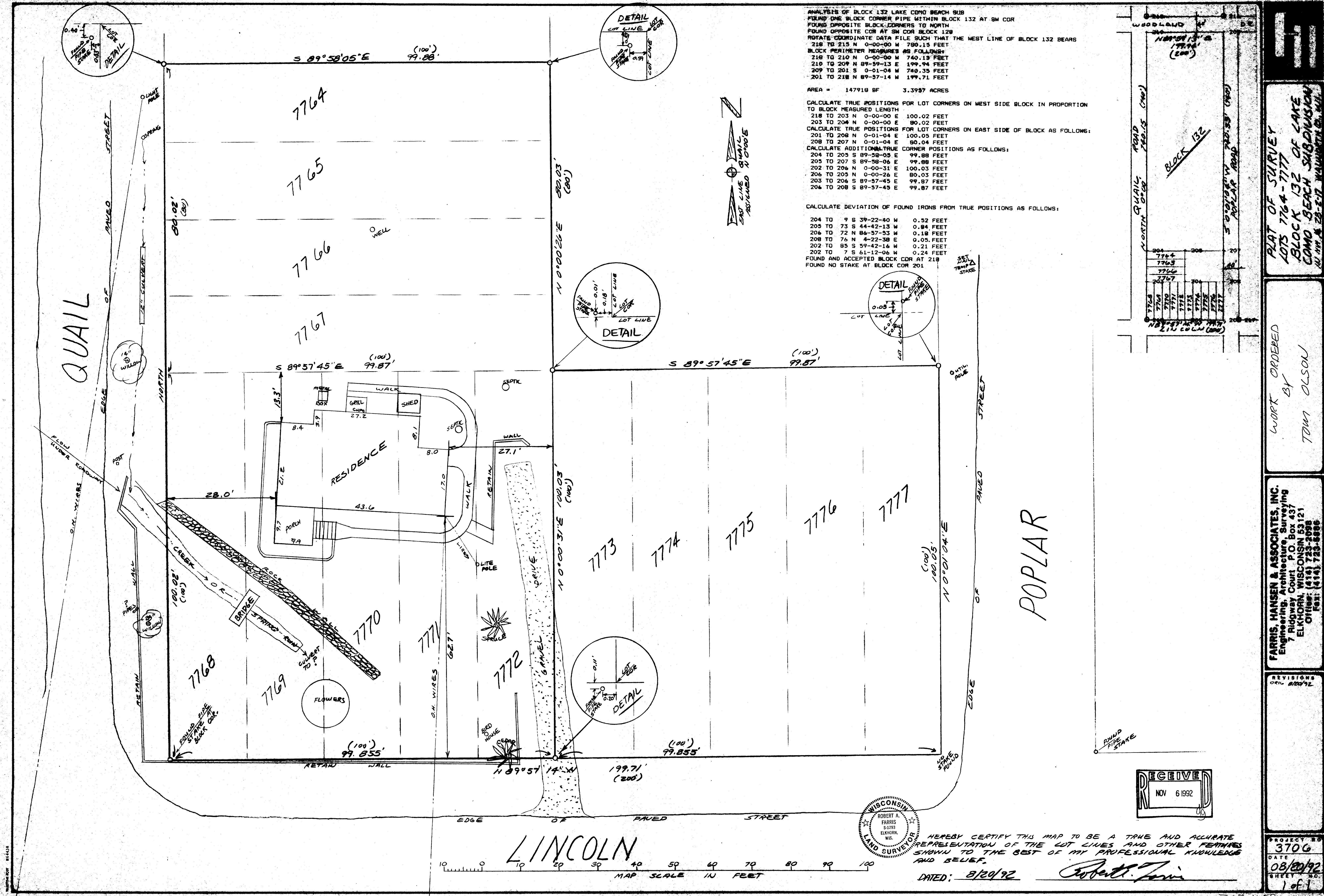
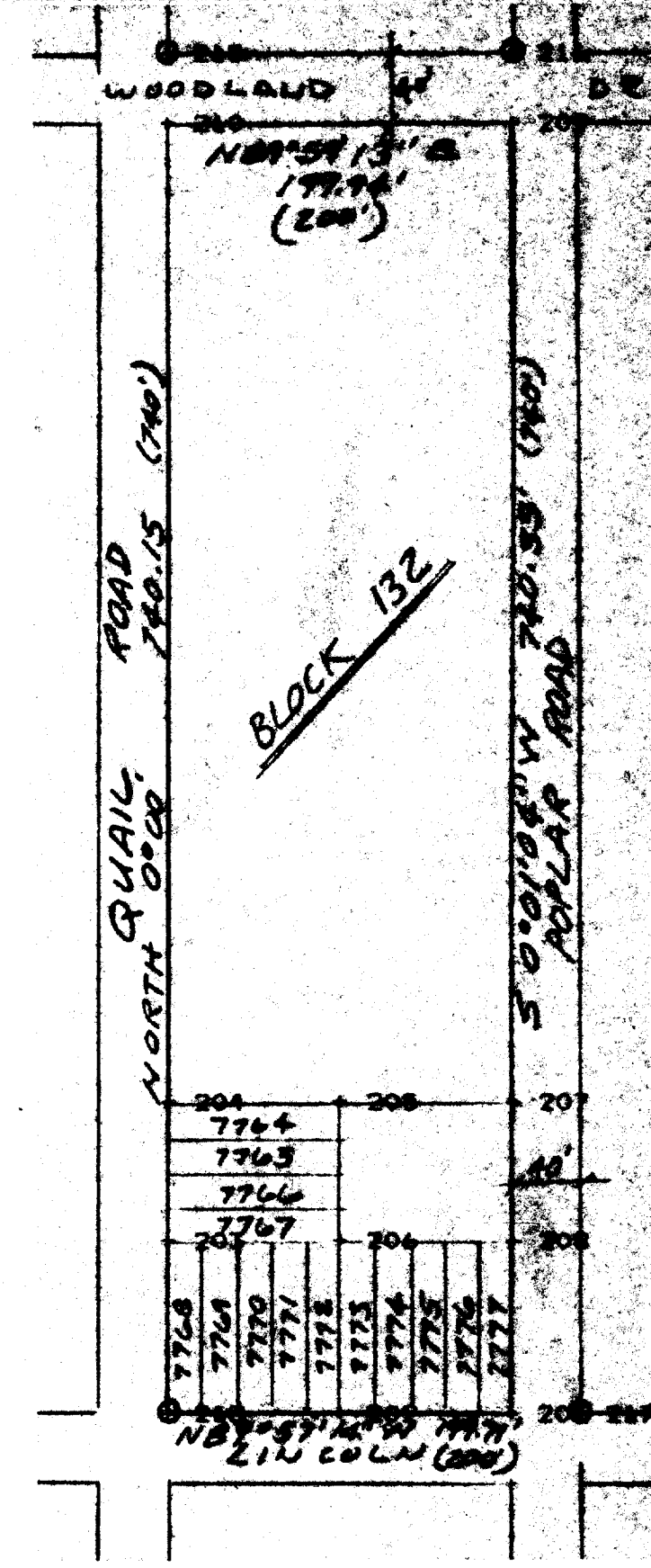

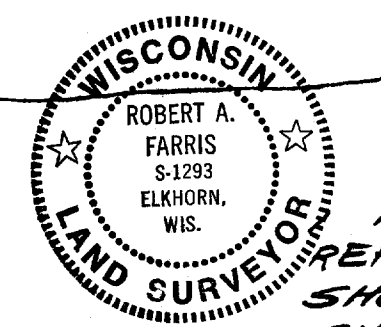


PLAT OF SURVEY

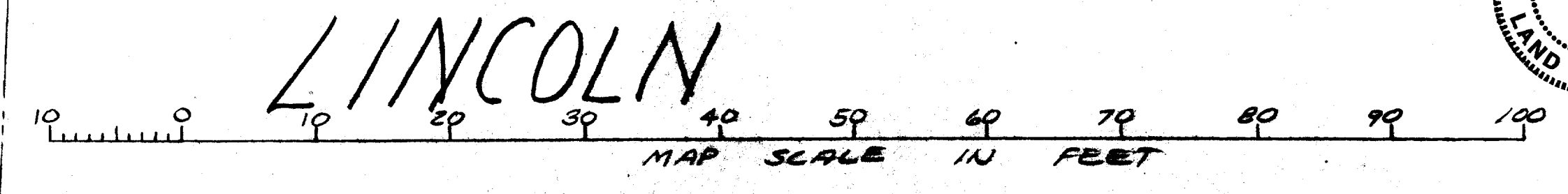
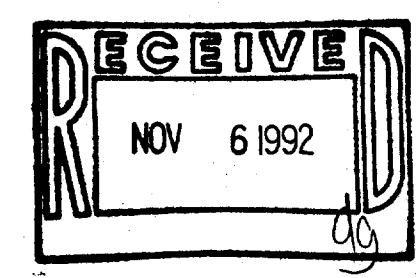
