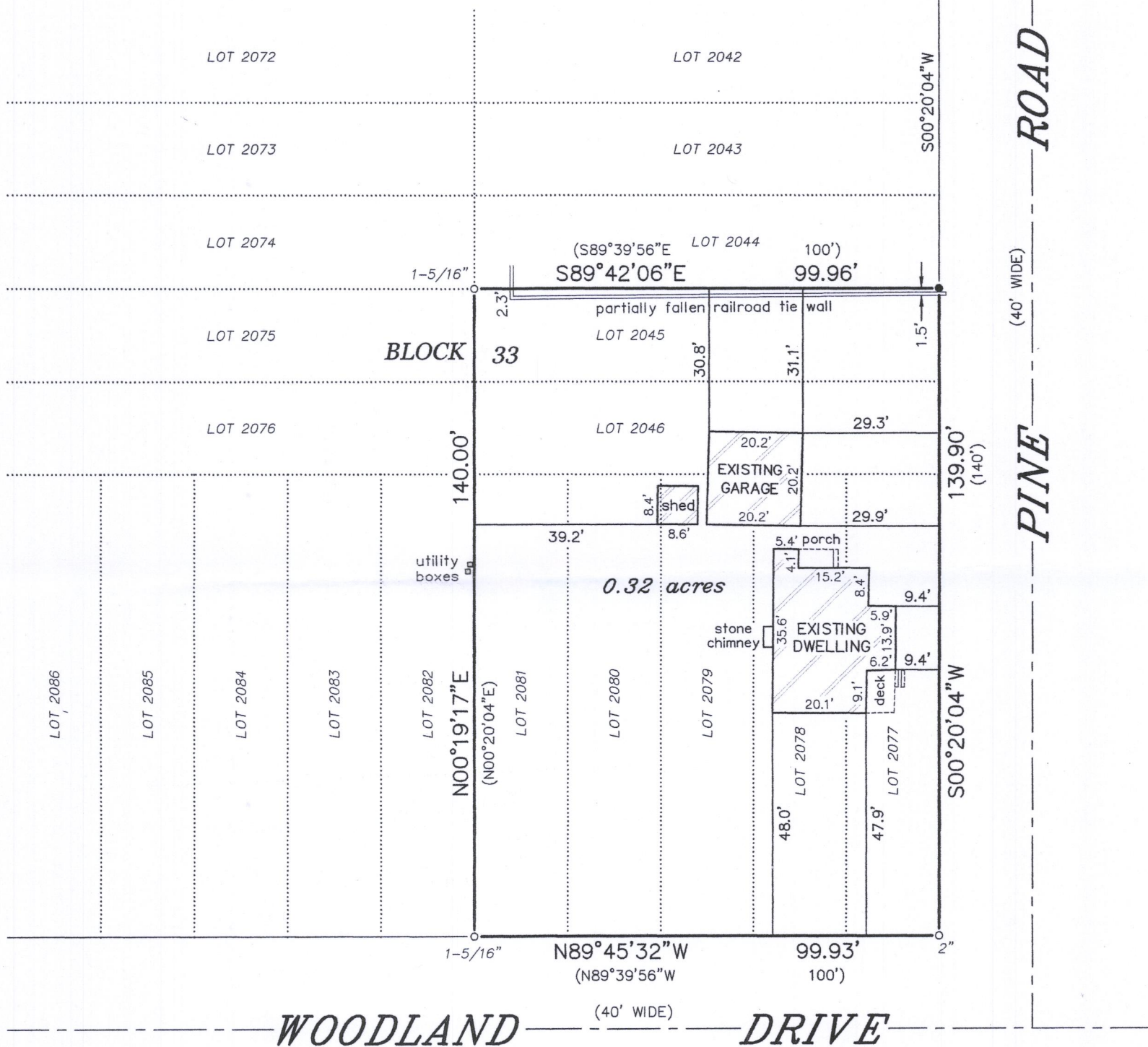

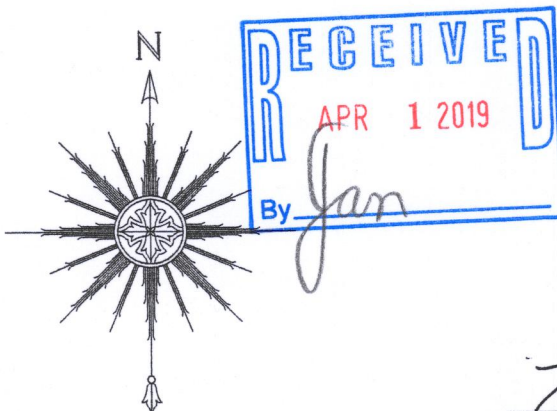
NOTE: RAILROAD TIE RETAINING WALL NEAR THE NORTH PROPERTY LINE LEANS TO THE SOUTH AND APPEARS TO BE FALLEN DOWN IN SPOTS. SNOW COVER MADE IT VERY DIFFICULT TO IDENTIFY THE ORIGINAL LOCATION OF THE WALL. TIES AS DEPICTED HEREON ARE TO THE SOUTH SIDE OF THE WALL AS IT CURRENTLY EXISTS. ALSO, DRIVEWAY WAS SNOW COVERED AND NOT LOCATED AS PART OF THIS SURVEY.

BEARINGS HEREON RELATE TO THE WEST LINE OF PINE ROAD AS DEPICTED HEREON. ASSUMED BEARING OF SOUTH 00°20'04" WEST AS PLATTED.
