

TIMBER TRAILS



LOCATED IN THE NORTHEAST 1/4 AND THE NORTHWEST 1/4

LEGAL DESCRIPTION

DESCRIPTION: Parcel 21
That part of the Northeast 1/4 and the Northwest 1/4 of Section 2, Town 3 north, Range 15 East, in the Town of Richmond, Walworth County, Wisconsin, bounded and described as follows:
Commencing at the center of said Section, said center being 2635.68 feet S 88° 29' 23" W of the Southeast corner of said Northeast 1/4 Section; thence S 88° 34' 51" W, along the South line of said Northwest 1/4 Section, 276.39 feet to a point; thence N 20° 07' 22" W, 318.85 feet to a point in the centerline of a proposed road, thence easterly along said centerline being a curved line having a radius of 325.00 feet with its center to the North and a chord 27.66 feet in length which bears N 85° 26' 19" E, an arc distance of 27.66 feet to a point of tangency; thence N 83° 00' 00" E, along said centerline, 111.77 feet to a point of curve; thence northeasterly along said centerline (being a curved line having a radius of 236.99 feet with its center to the north and a chord 285.25 feet in length which bears N 46° 00' 00" E), and arc distance of 306.09 feet to a point of reversed curve; thence northeasterly, along said centerline (being a curved line having a radius of 309.54 feet with its center to the southeast and a chord 36.72 feet in length which bears N 12° 24' 00" E), an arc distance of 36.74 feet to a point; thence S 31° 13' 46" E, 643.46 feet to a point in the South line of said Northeast 1/4 Section; thence S 88° 29' 23" W, along the South line of said Northeast 1/4 Section, 395.61 feet to the point of beginning. Containing therein 5.0237 acres of land.
