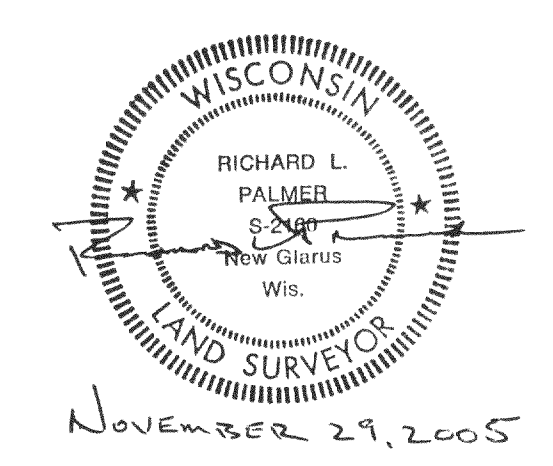
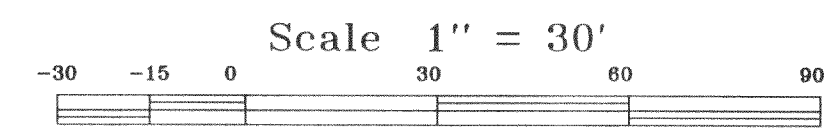




Description of Parcel A:
