

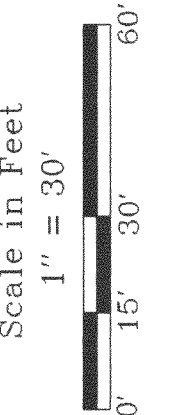

Proposed Lot Line Adjustment

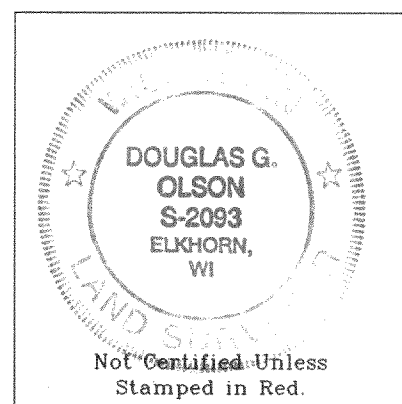
Part of Lot 31 of Block 4 of Lake Wandewega Highlands, a subdivision located in the Northeast 1/4 of Section 11 and the Northwest 1/4 of Section 12, Town 3 North, Range 16 East, Town of Sugar Creek, Walworth County, Wisconsin, more particularly described as follows: Begin at an iron pipe marking the Southwest corner of said Lot 31; thence North 11°59'18" West, along the West line of said Lot 31, 189.90 feet to a point on the South line of Tecumshe Trail; thence Southeasterly along said South line and the arc of a curve to the left (Central angle=1°35'41", radius=730.43 feet, whose chord bears South 88°19'21" East, 20.33 feet; thence South 12°03'56" East 186.75 feet; thence South 82°44'07" West, along the South line of said Lot 31, 20.07 feet to the Point of Beginning. Said parcel contains 0.086 acre (3,743 sq.ft.) of land, more or less, and is a lot line adjustment between adjacent parcels.
