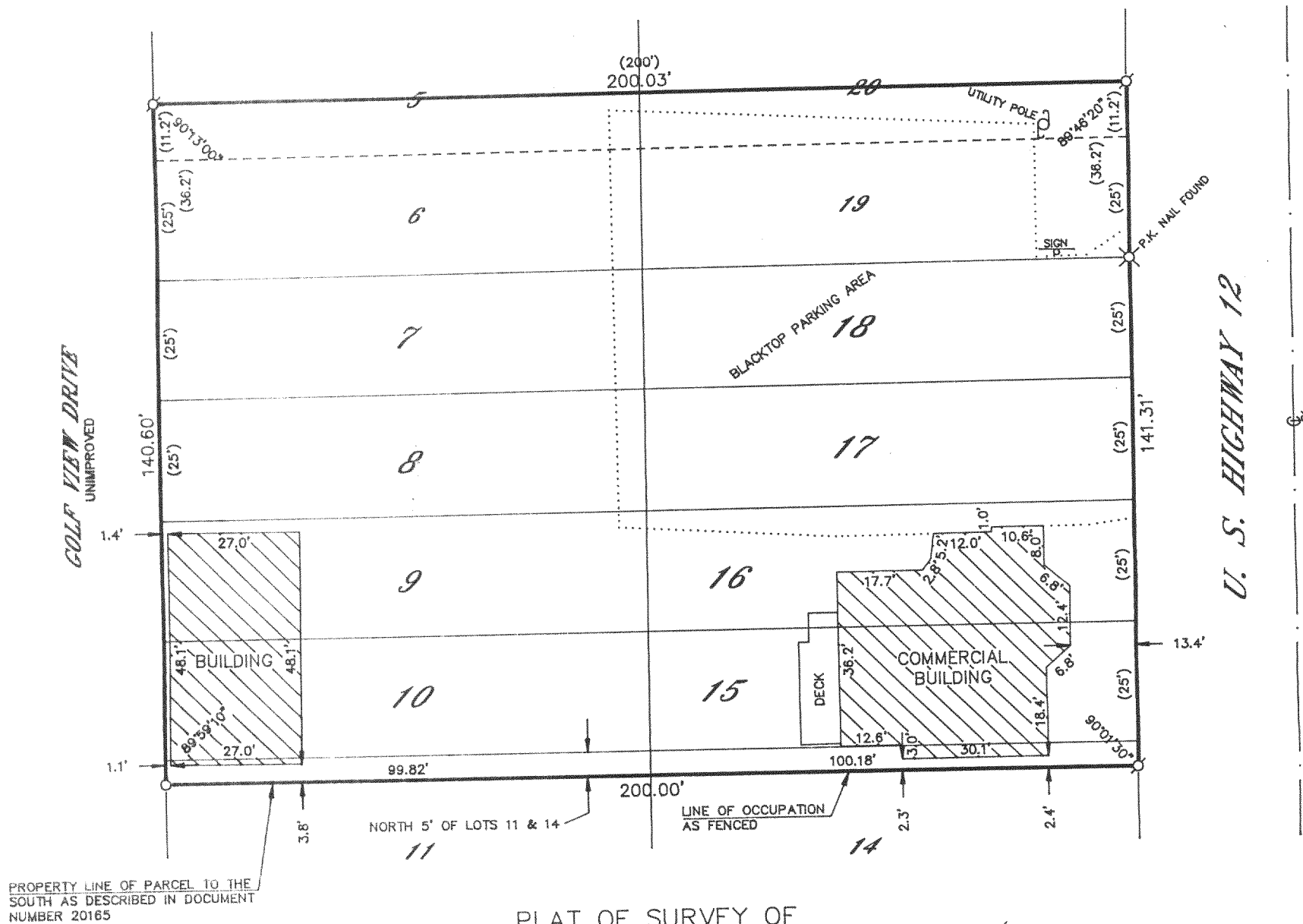

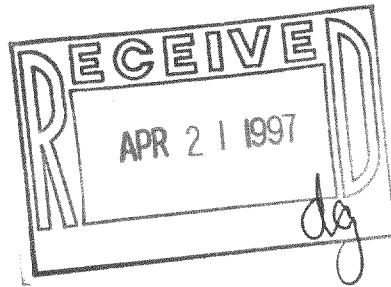

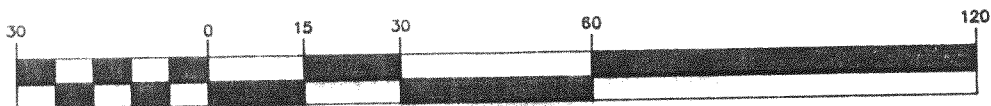

S. HIGHWAY 12; THENCE SOUTH 36.2 FEET TO THE NORTHEAST CORNER OF LOT 18 IN BLOCK 23 OF LAKE WANDAWEGA SUBDIVISION, GOLF PARK ADDITION; THENCE WEST ALONG THE NORTH LINES OF SAID LOTS 18 AND 7 IN BLOCK 23, 200 FEET MORE OR LESS TO THE PLACE OF BEGINNING.
