OF THE 4TH P.M., TOWNSHIP OF SPRING PRAIRIE, COUNTY OF WALWORTH, STATE OF WISCONSIN AND MORE PARTICULARLY DESCRIBED AS FOLLOWS : COMMENCE AT A STONE MONUMENT AT THE SOUTHWEST CORNER OF SAID SECTION 13, THENCE N. $0^{\circ}08'30''$ E., ALONG THE WEST LINE OF SAID QUARTER SECTION, 963.92 FEET TO POTTER ROAD; THENCE N. $88^{\circ}17'$ E., ALONG POTTER ROAD, 376.97 FEET TO THE PLACE OF BEGINNING OF PARCEL OF LAND HEREINAFTER DESCRIBED: THENCE CONTINUE N. $88^{\circ}17'$ E., ALONG POTTER ROAD, 44.40 FEET; THENCE N. $86^{\circ}08'18''$ E., ALONG POTTER ROAD, 256.79 FEET; THENCE N. $5^{\circ}27'$ W., 881.52 FEET TO AN IRON PIPE STAKE; THENCE S. $85^{\circ}51'$ W., 301.08 FEET TO AN IRON PIPE STAKE; THENCE S. $5^{\circ}27'$ E., 878.38 FEET TO THE PLACE OF BEGINNING. CONTAINING 6.08 ACRES OF LAND. SUBJECT TO THE RIGHTS OF THE PUBLIC OVER THE SOUTH SIDE FOR HIGHWAY PURPOSES. (POTTER ROAD). CONTAINING 5.852 ACRES OF LAND EXCLUSIVE OF ROAD.
