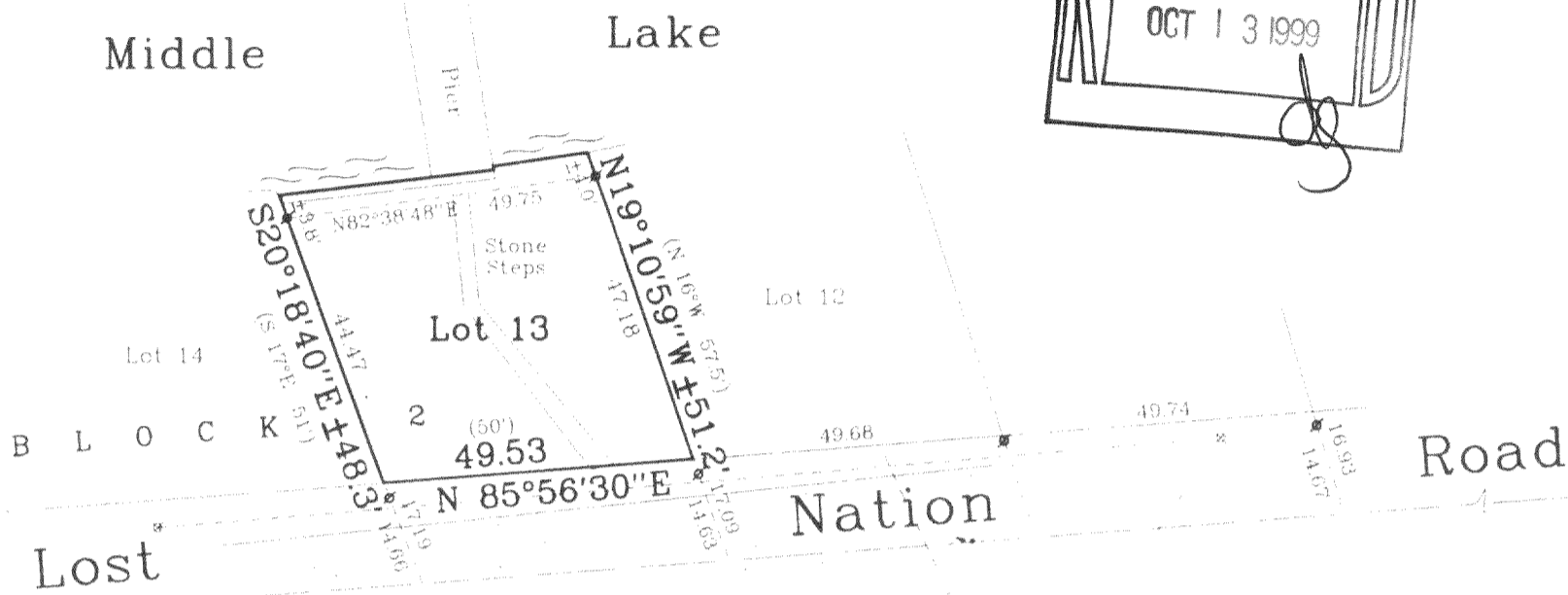
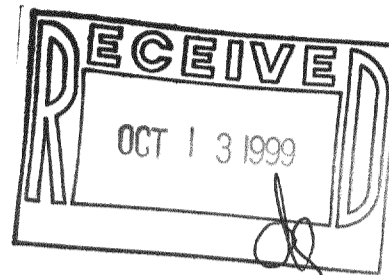

A parcel of land described in a Warranty Deed recorded in Vol. 630 on Page 564 as Document No. 579019 and as shown below:

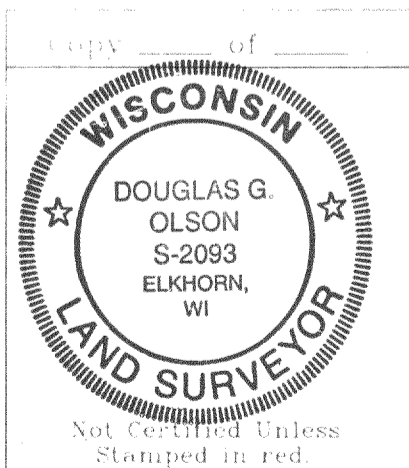
