

PLAT OF SURVEY

PARCEL 1:

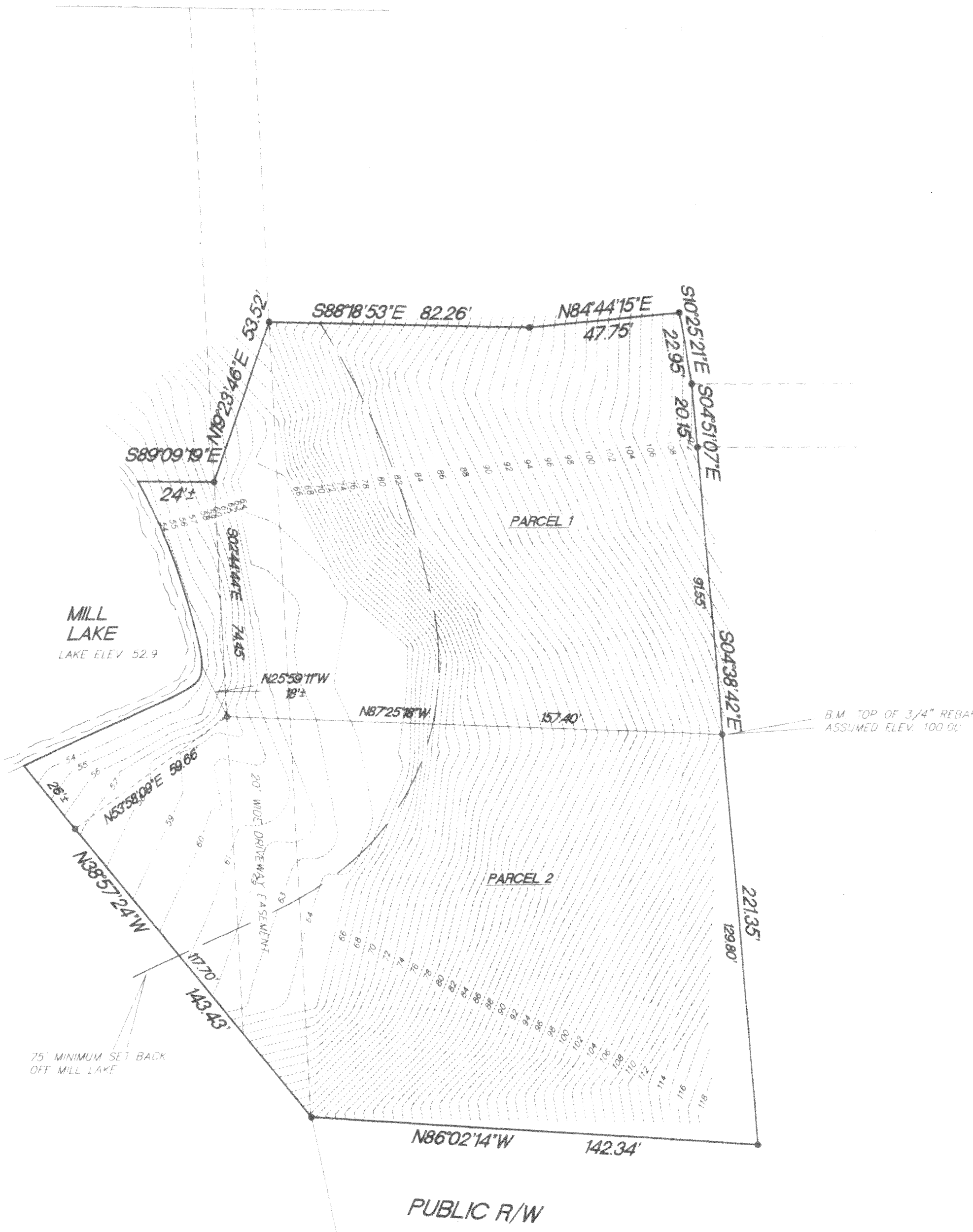
A parcel of land being part of Carswells Park, located in Sections 35 and 36, Town 4 North, Range 16 East, Walworth County, Wisconsin, described as follows: Commencing at the shore of Mill Lake at the most Northerly corner of Certified Survey Map No. 627, Recorded in Volume No. 3 on Page No. 95 of Walworth County Certified Survey Maps; thence along the shore of said Mill Lake Northeasterly 65 feet more or less to the point of beginning; thence continue along said lake, 60 feet more or less to a point located North 89°09'19" West 20.95 feet from an iron pipe stake; thence South 89°09'19" East, 20.95 feet to said iron pipe stake; thence North 19°23'46" East 53.52 feet to an iron pipe stake; thence South 88°18'53" East 82.26 feet to an iron pipe stake; thence South 84°44'15" East 47.75 feet to an iron pipe stake; thence South 10°25'21" East 22.95 feet to an iron pipe stake; thence South 04°51'07" East 20.15 feet to an iron pipe stake; thence South 04°38'42" East 91.55 feet; thence North 87°25'18" West 157.40 feet; thence North 25°59'11" West 19.08 feet to the point of beginning. Containing 20,105 square feet of land (0.46 acres) more or less.

PARCEL 2:

A parcel of land being part of Carswells Park, located in Sections 35 and 36, Town 4 North, Range 16 East, Walworth County, Wisconsin, described as follows: Beginning at the shore of Mill Lake at the most Northerly corner of Certified Survey Map No. 627, Recorded in Volume No. 3 on Page No. 95 of Walworth County Certified Survey Maps; thence along the shore of said Mill Lake Northeasterly 65 feet more or less; thence South 25°59'11" East 19.08 feet; thence South 87°25'18" East 157.40 feet; thence South 04°38'42" East 129.80 feet to an iron pipe stake; thence North 86°02'14" West 142.34 feet to an iron pipe stake marking said CSM 627; thence North 38°57'24" West 142.80 feet along said Certified Survey to the point of beginning. Containing 23,800 square feet of land (0.55 acres) more or less.

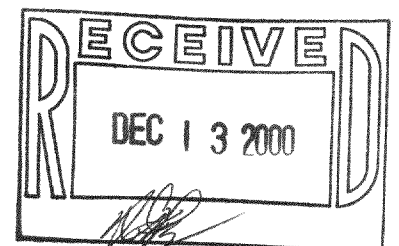
