

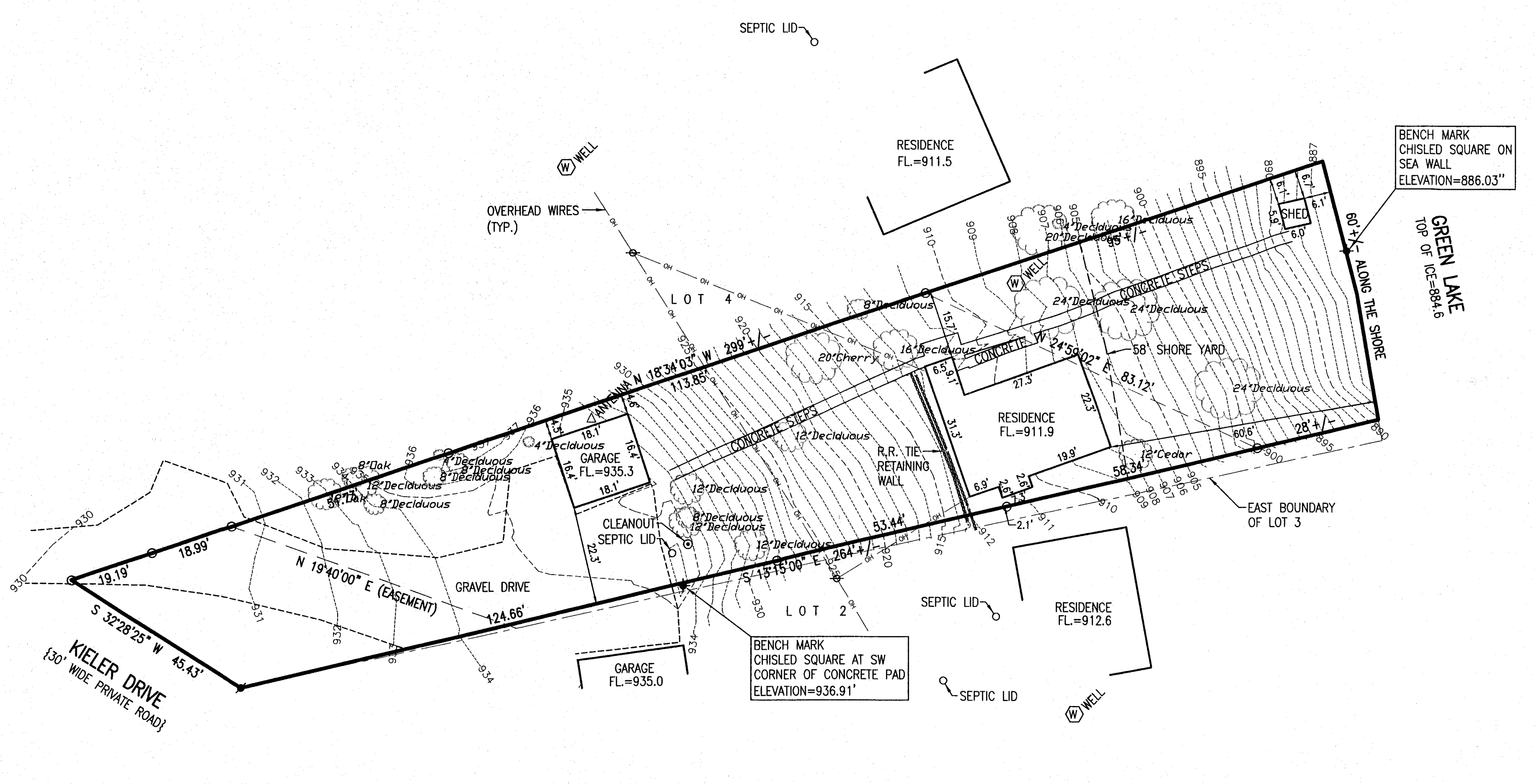
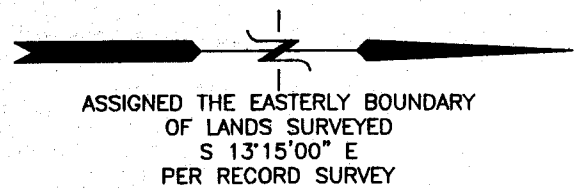
PLAT OF SURVEY & TOPOGRAPHIC MAPPING PART OF LOT 3 OF SOLID COMFORT SUBDIVISION

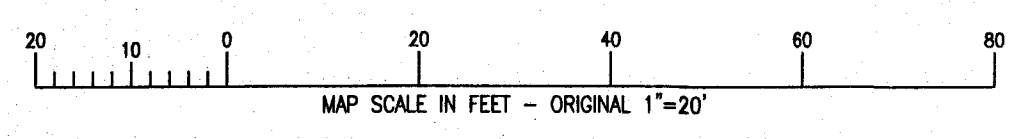

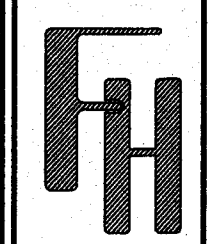
