Also to include the lands lying between the above described meander line and the shore of Middle Lake as encompassed by the above described bearings and distances from said meander line to the shore.

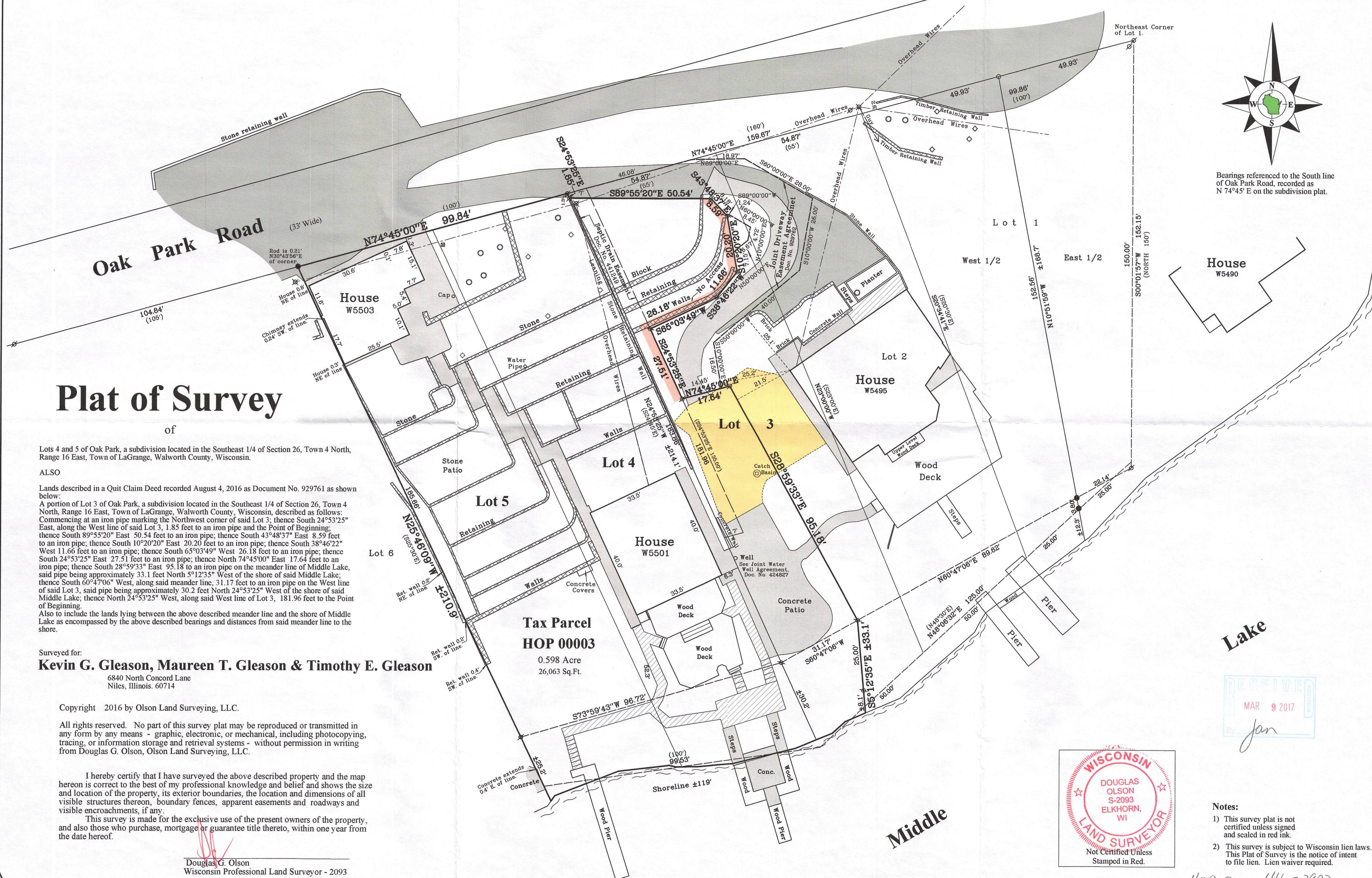
