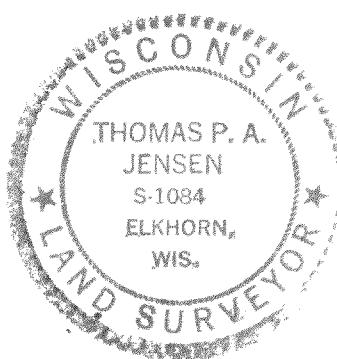

All that certain piece or parcel of land lying and being in the North East One-quarter (1/4) of Section Twenty-four (24), in Township Four (4) North, Range Seventeen (17) East, in the Town of Troy, described as follows, to-wit: Beginning at the most Southerly corner of the lot conveyed by William Dawe and wife to F.A. Harris, the deed of which conveyance is on record in the Register of Deed's Office in and for said County in Volume 177 of Deeds on Page 23, running thence North-easterly being along the Southeasterly line of the said Harris lot 230 feet to an iron stake and 5 feet more, more or less, to the shore of Booth Lake; thence Southeasterly along the said shore to the Northwesterly corner of the lot owned and occupied by Mrs. Emil Linde, and being more fully described in a deed of conveyance from William Dawe and wife, to Emma Bergwall, which deed is on record in said Register of Deed's Office in Volume 117 of Deeds on Page 366, thence Southwesterly being along the said Linde line 5 feet more or less to an iron stake and 280 feet more, more or less to an iron stake at the angle in the said line; thence Southerly being also along the said Linde line 290 feet more or less to an iron stake on the Northeasterly line of a road or drive; thence Northwesterly 493 feet more or less to the place of beginning.

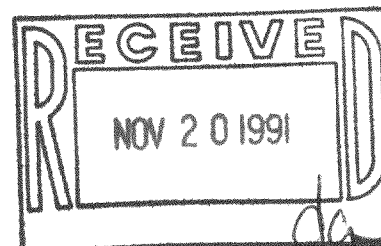
