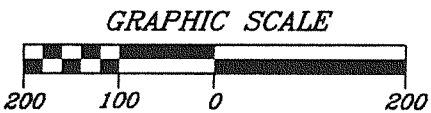


NORTH LINE OF THE NW 1/4 OF SECTION 21-4-17 N89°41'35"E 769.57'

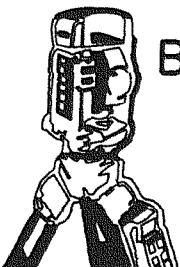

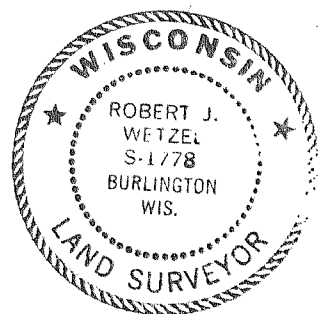
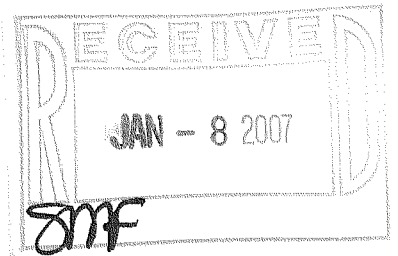
