

THAT PART OF LOT 9 AND 10 IN LAKE BEULAH MANOR, BEING A PART OF THE WEST 1/2 OF SECTION 9, TOWNSHIP 4 NORTH, RANGE 18 EAST, IN THE TOWN OF EAST TROY, BOUNDED AND DESCRIBED AS FOLLOWS: COMMENCING AT A POINT BEING THE NORTHWESTERLY POINT OF LOT 10; THENCE RUNNING SOUTHWESTERLY, ALONG AND UPON THE WESTERLY LINE OF LOT 10, 43.7 FEET TO A POINT; THENCE EASTERLY AND PARALLEL TO THE SOUTHERLY LINE OF LOT 10 TO THE SHORE OF LAKE BEULAH; THENCE NORTHEASTERLY ALONG AND UPON THE SHORE OF LAKE BEULAH TO THE NORTHERLY LINE OF LOT 10; THENCE ALONG AND UPON THE NORTHERLY LINE OF LOT 10 TO THE PLACE OF COMMENCEMENT. ALSO: COMMENCING AT A POINT BEING THE NORTHWESTERLY POINT OF LOT 10; THENCE RUNNING NORTHEASTERLY, ALONG AND UPON THE WESTERLY LINE OF LOT 9, 11 FEET TO A POINT; THENCE EASTERLY AND PARALLEL TO THE SOUTHERLY LINE OF LOT 9 TO THE SHORE OF LAKE BEULAH; THENCE SOUTHWESTERLY ALONG AND UPON THE SHORE OF LAKE BEULAH TO THE SOUTHERLY LINE OF LOT 9; THENCE ALONG AND UPON THE SOUTHERLY LINE OF LOT 9 TO THE PLACE OF COMMENCEMENT.

ALSO: PART OF THE SOUTHERLY 10 FEET OF LOT 10 IN LAKE BEULAH MANOR ACCORDING TO THE RECORDED PLAT THEREOF AND BEING IN THE WEST 1/2 OF SECTION 9, TOWNSHIP 4 NORTH, RANGE 18 EAST OF THE FOURTH PRINCIPAL MERIDIAN IN THE TOWN OF EAST TROY, COUNTY OF WALWORTH AND STATE OF WISCONSIN AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: COMMENCE AT THE SOUTHWEST CORNER OF LOT 12 OF LAKE BEULAH MANOR; THENCE NORTH 36°34' EAST, 173.06 FEET TO THE POINT OF BEGINNING OF A PARCEL OF LAND HEREINAFTER DESCRIBED; THENCE CONTINUE NORTH 36°34' EAST 2.14 FEET; THENCE SOUTH 74°15'17" EAST (RECORDED AS SOUTH 73°56' EAST) 243.4 FEET MORE OR LESS TO THE SHORELINE OF LAKE BEULAH; THENCE SOUTHWESTERLY ALONG SAID SHORELINE 2.00 FEET MORE OR LESS; THENCE NORTH 74°15'17" WEST, 75.9 FEET MORE OR LESS; THENCE NORTH 15°44'43" EAST, 2.00 FEET; THENCE NORTH 74°15'17" WEST, 85.97 FEET; THENCE SOUTH 15°44'43" WEST, 2.00 FEET; THENCE NORTH 74°15'17" WEST, 82.00 FEET TO THE POINT OF BEGINNING.
