BEGINNING AT AN IRON PIPE IN CONCRETE MARKING POINT "C" OF SAID WILLIAMS PARK PLAT; THENCE S87°45'00"W ALONG THE RIGHT OF WAY FOR HORSESHOE LANE, 153.89' TO A FOUND IRON PIPE, SAID POINT BEING THE POINT OF BEGINNING; THENCE S14°41'28"W, 316.95' TO A FOUND IRON PIPE IN CONCRETE, SAID POINT BEING ON A MEANDER LINE ON THE SHORE OF LAKE BEULAH; THENCE N38°12'09"W ALONG SAID MEANDER LINE, 200.07' TO A POINT ON A LINE CONVEYED TO MACKAY, THE DEED OF WHICH IS RECORDED IN VOLUME 174 OF DEEDS ON PAGE 608 AT THE WALWORTH COUNTY REGISTER OF DEEDS OFFICE; THENCE N35°05'56"E, 267.70' TO A POINT ON THE RIGHT OF WAY FOR HORSESHOE LANE; THENCE S38°00'28"E ALONG SAID RIGHT OF WAY 86.28' TO THE POINT OF BEGINNING. SAID PARCEL CONTAINS LAND BETWEEN SAID MEANDER LINE AND THE ORDINARY HIGH WATER MARK FOR LAKE BEULAH.

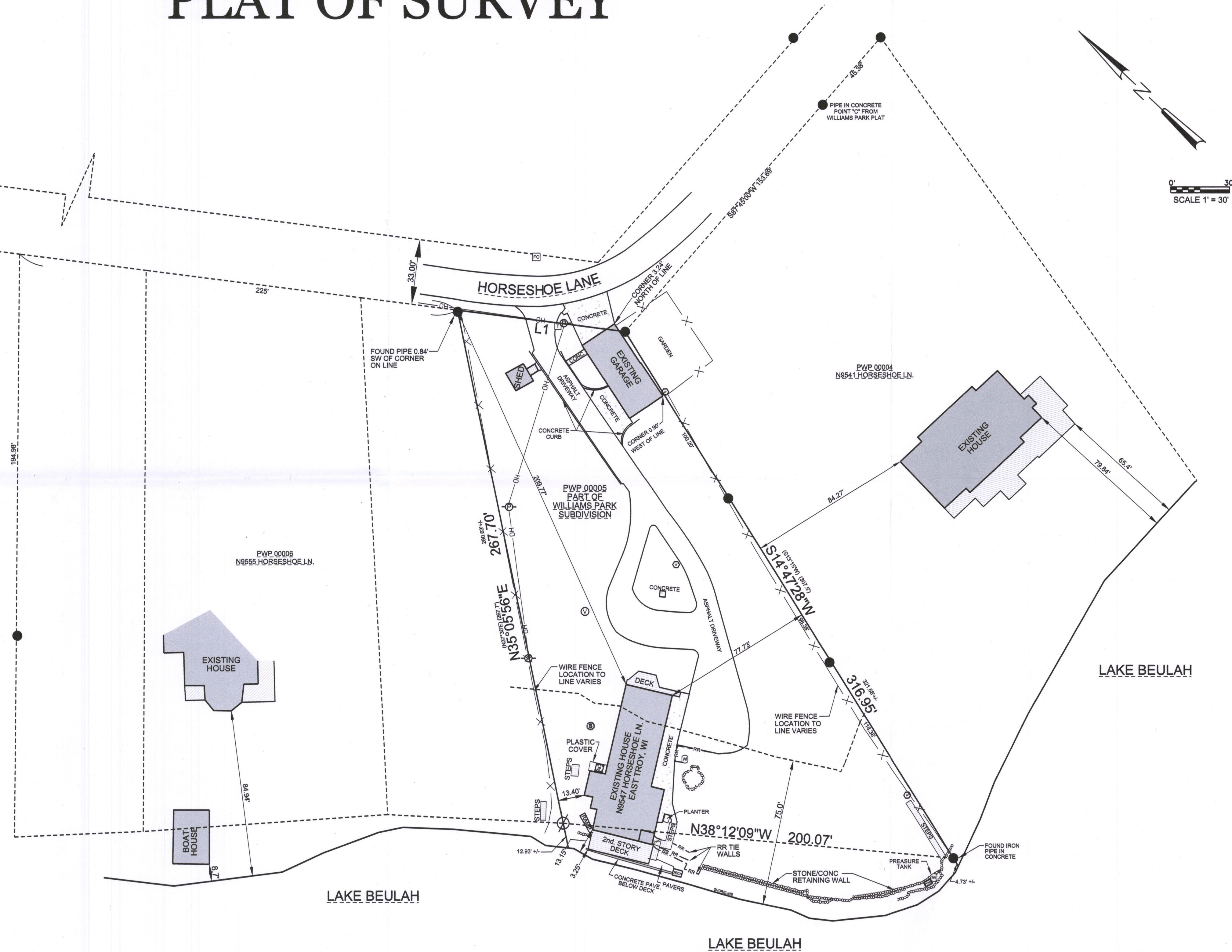
