Beginning at a stake and which stake is in line with the most southerly line of the Plat of Lake View and which plat is on record in the Register of Deeds Office of Walworth County, Wisconsin, in Vol 4 of Plats on page 37; and being 65 feet southwesterly from the southeasterly corner of lot 7, of said Plat; Thence northwesterly 285.7 feet to a stake in line with the base line of said plat and 50 feet distant from a stake on said line on the southwesterly side of said lot 7, and producing or extending said line northwesterly 23 feet more or less to the shore of Delavan Lake, at low water line; Thence southerly along the shore of said lake at low water line 60 feet more or less to a point; Thence southeasterly 34 feet more or less to a stake being in line with the base line of the above mentioned plat and 110 feet distant from a stake on the most southerly line of said lot 7 and producing or extending the above mentioned line southeasterly 306.4 feet more to a stake in the center of an certain road; Thence northwesterly 56.2 feet to an angle stake in said road and 10.8 feet more to the corner of the lands being described; Thence northwesterly 35.5 feet to the place of beginning.

Beginning at an iron monument at the northeast corner of That certain piece or parcel of land, known as Lake View Sub., the Plat of which is on record in the Register of Deeds Office, in and for the said County, in Vol. No. 6, of plats, on page 159; Thence South being along the East line of the said Plat 16.4 feet to a stake. Thence East, being at right angles to the East line of the said Plat, 135 feet to a stake on the West side of a street or drive; Thence north, being parallel with the East line of the said Subdivision, and on the West line of the said street or drive 95.7 feet to a stake on the South Easterly side of a second street or drive; Thence Southwesterly, along the southeasterly side of said street or drive, 151.6 feet to the place of beginning. Being lot no. I of Parcel C of an unrecorded plat, made for B. F. Hoag, by *Wm. Child*, County Surveyor - July 25 & 26, 1922.
