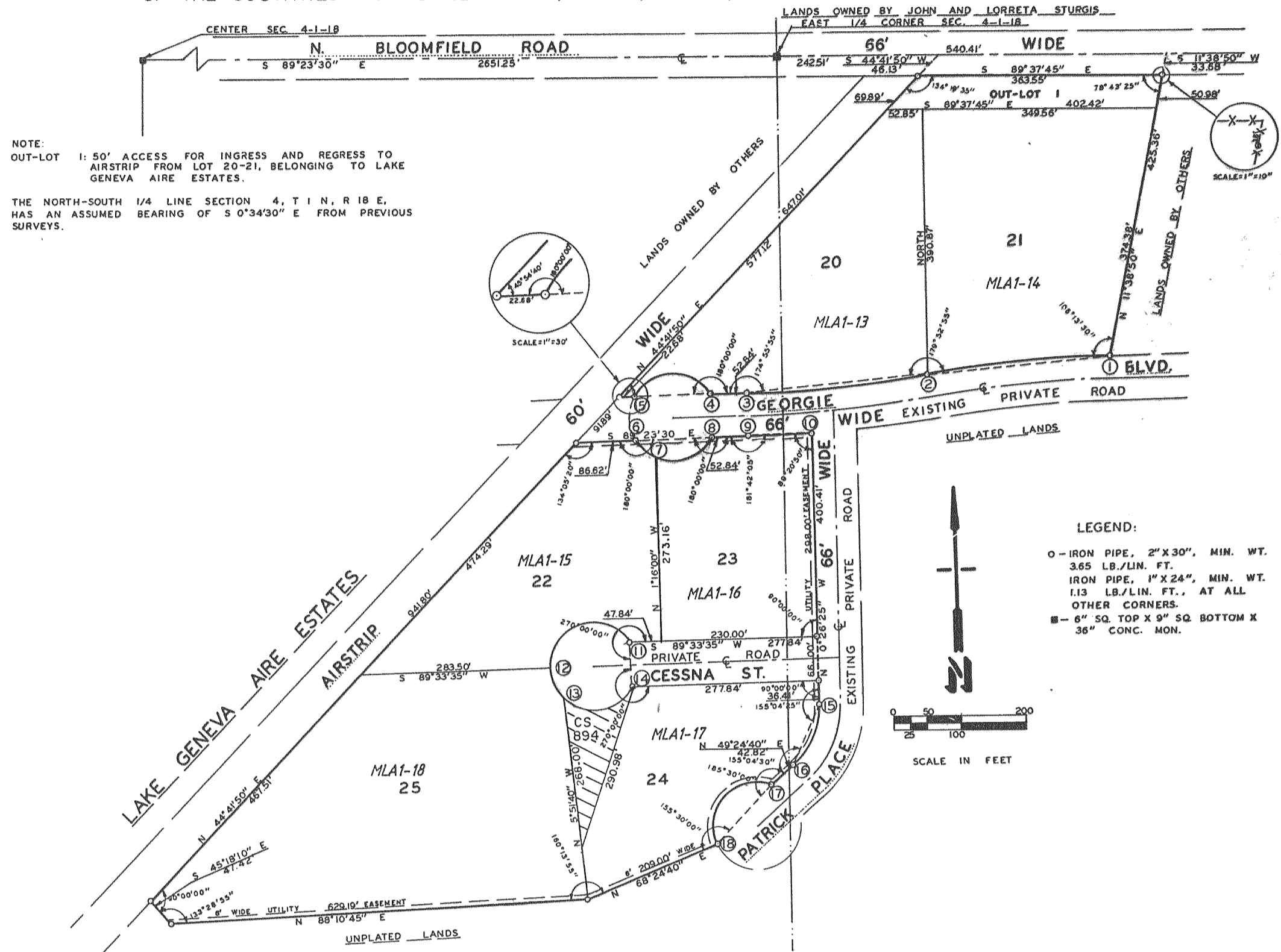


THE FIRST ADDITION TO LAKE GENEVA AIRE ESTATES
