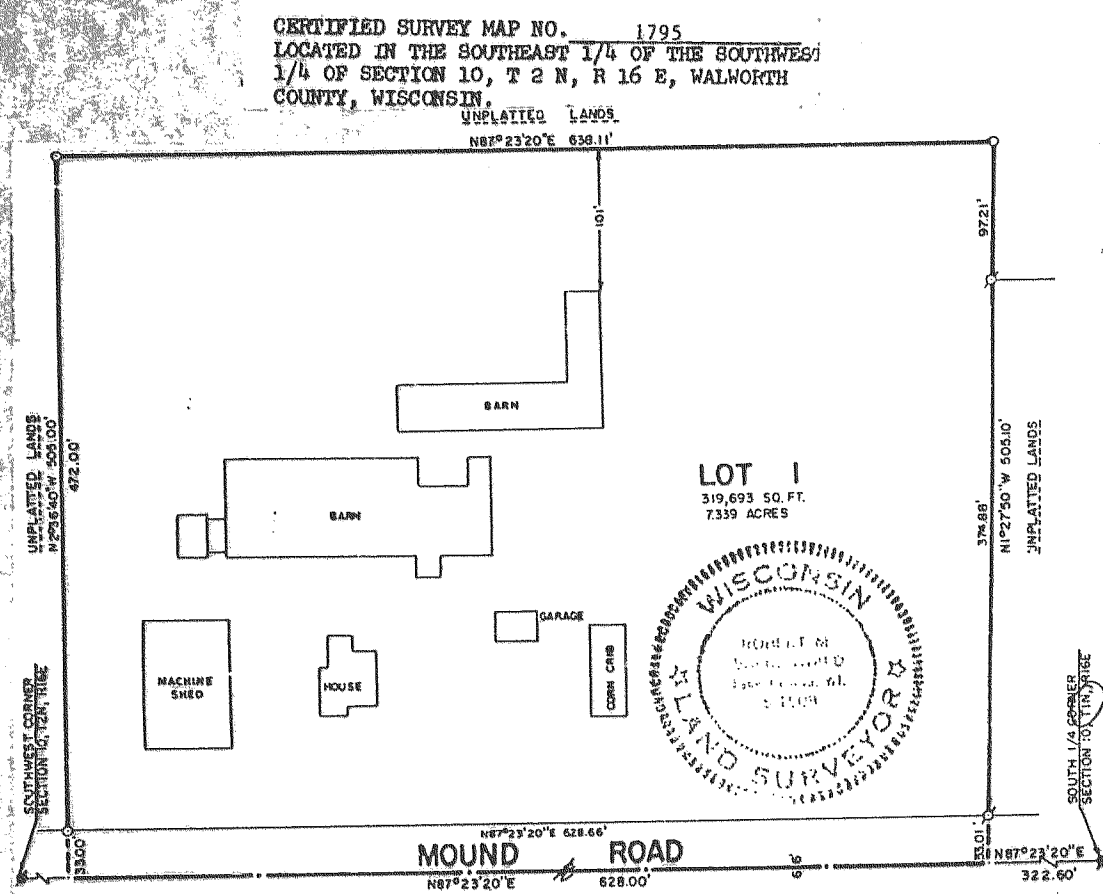

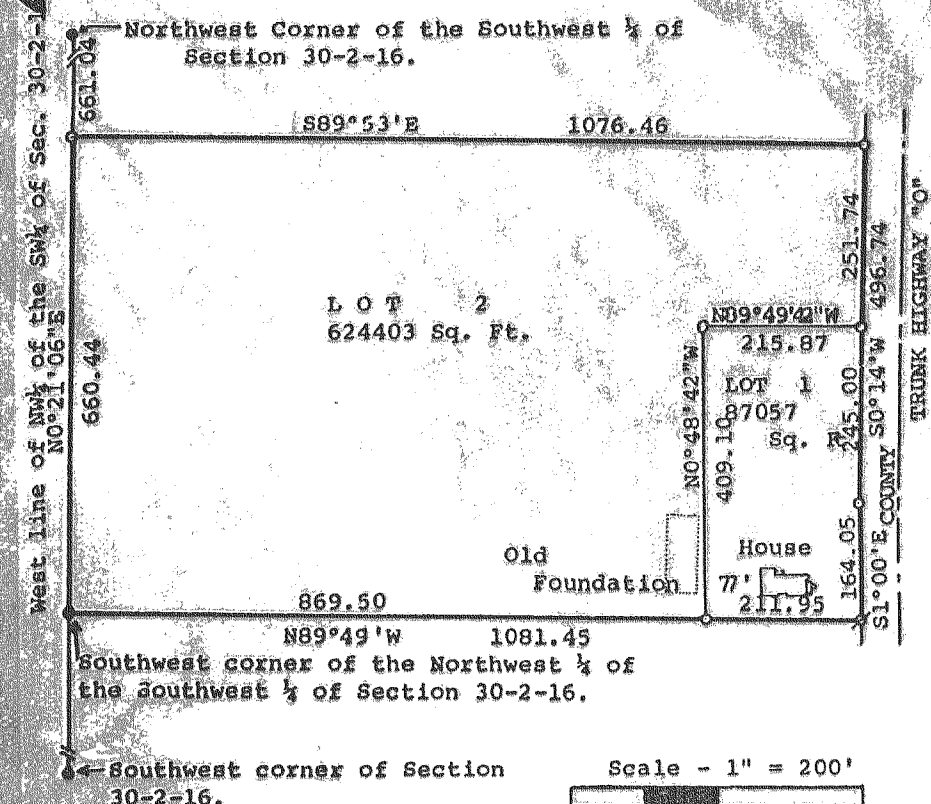


SURVEYOR'S CERTIFICATE:

I, ROBERT M. BAERENWALD, WISCONSIN REGISTERED LAND SURVEYOR, HEREBY CERTIFY THAT IN FULL COMPLIANCE WITH THE PROVISIONS OF CHAPTER 236.34 OF THE WISCONSIN STATUTES AND THE LAND DIVISION (SUBDIVISION) ORDINANCE OF WALWORTH COUNTY, AND UNDER THE DIRECTION OF PLEASANT PRAIRIE FARMS, INC., OWNER OF SAID LAND, I HAVE SURVEYED, DIVIDED AND MAPPED THIS CERTIFIED SURVEY, THAT SUCH PLAT CORRECTLY REPRESENTS ALL EXTERIOR BOUNDARIES AND THE SUBDIVISION OF THE LAND SURVEYED AND THAT THIS LAND IS LOCATED IN THE SOUTHEAST 1/4 OF THE SOUTHWEST 1/4 OF SECTION 10, T 2 N, R 16 E, WALWORTH COUNTY, WISCONSIN AND DESCRIBED AS FOLLOWS: COMMENCING AT THE SOUTH 1/4 CORNER OF SAID SECTION 10, THENCE S87°23'20"W 322.60 FEET TO THE PLACE OF BEGINNING; THENCE CONTINUE S87°23'20"W 628.00 FEET; THENCE N2°36'40"W 505.00 FEET; THENCE N87°23'20"E 630.11 FEET; THENCE S81°27'50"E 505.10 FEET TO THE PLACE OF BEGINNING, CONTAINING 7.339 ACRES OF LAND.

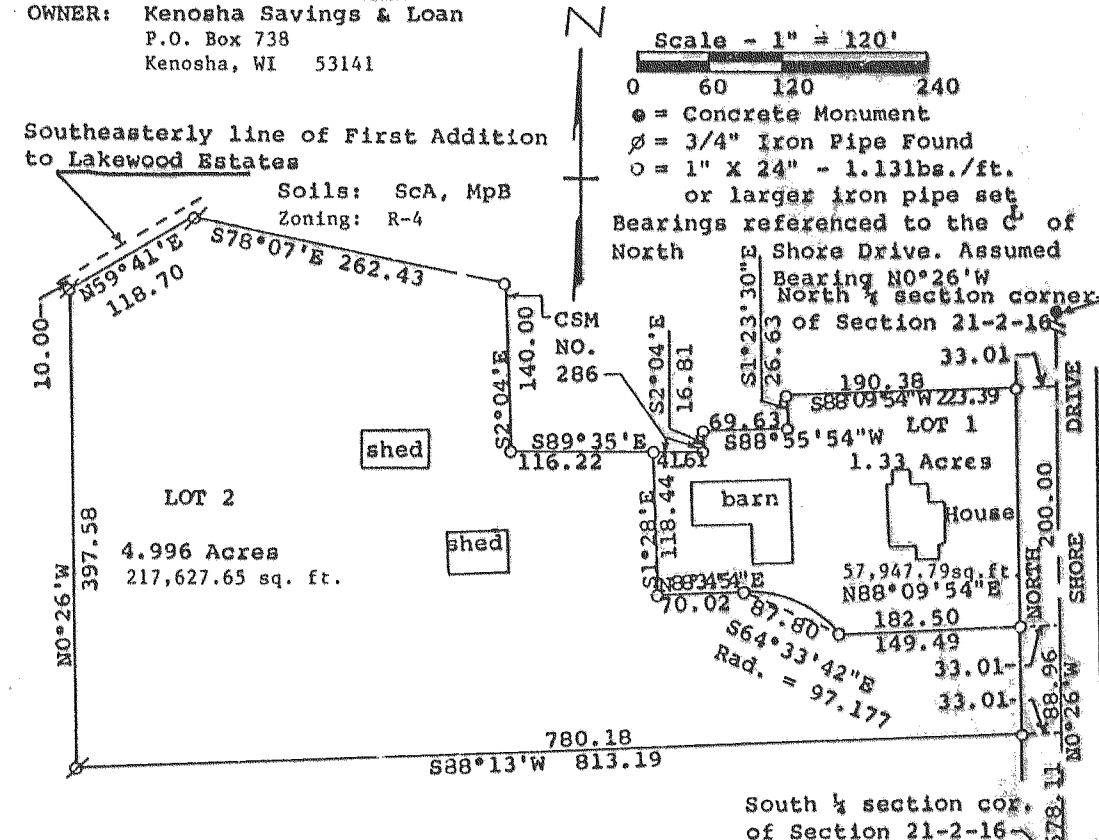
