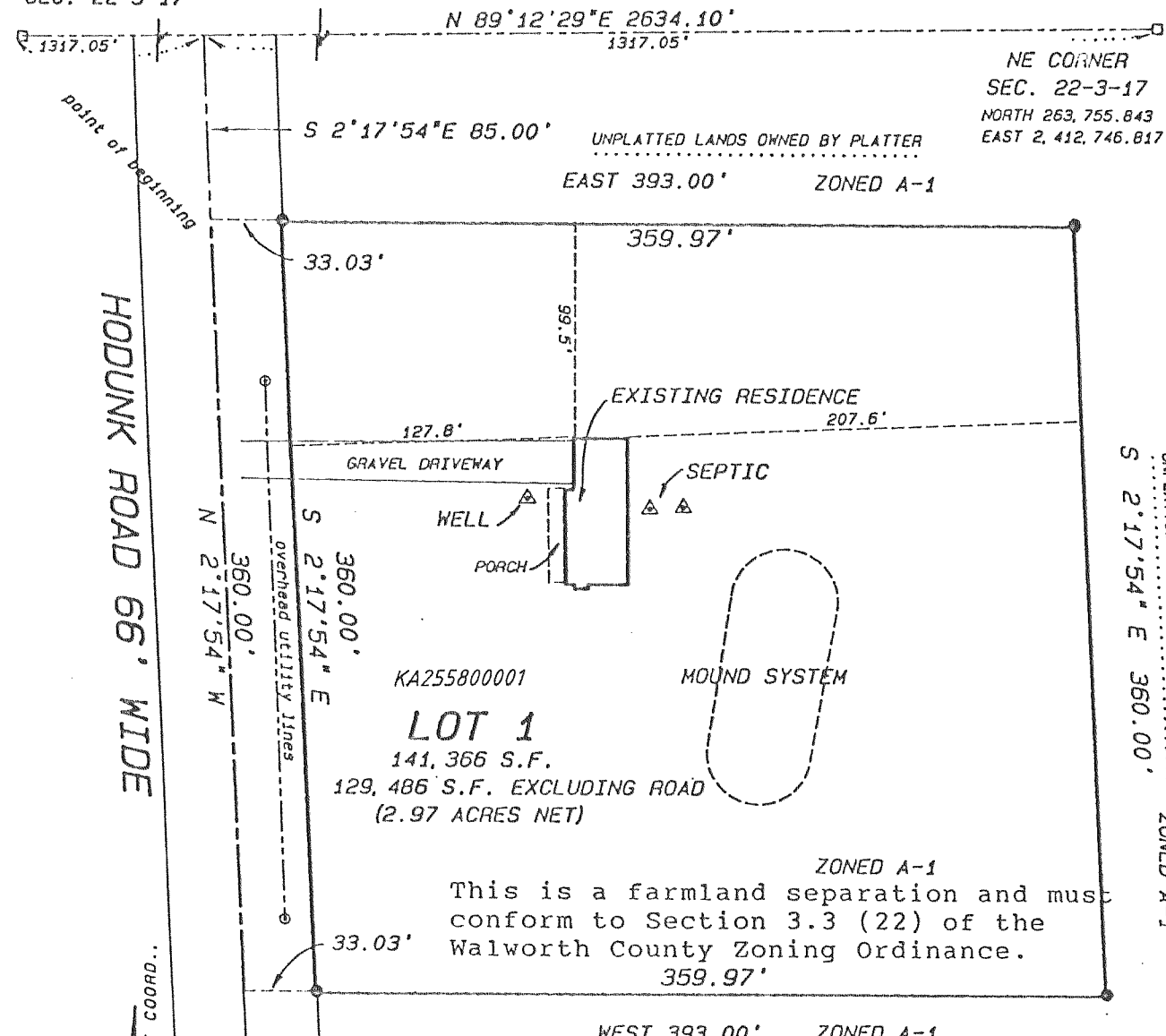

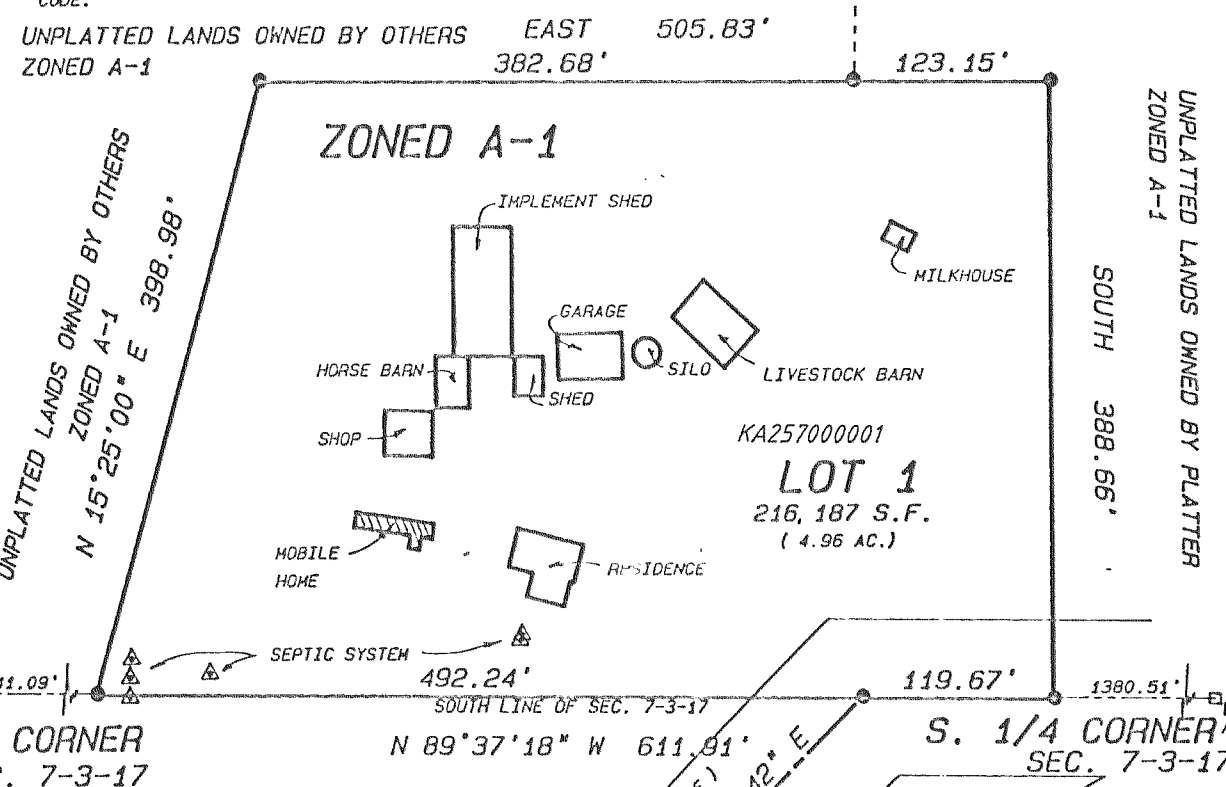

This is a farmland separation and must conform to Section 3.3(22) of the Walworth County Zoning Ordinance.

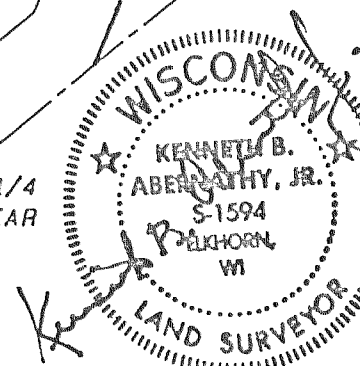
