

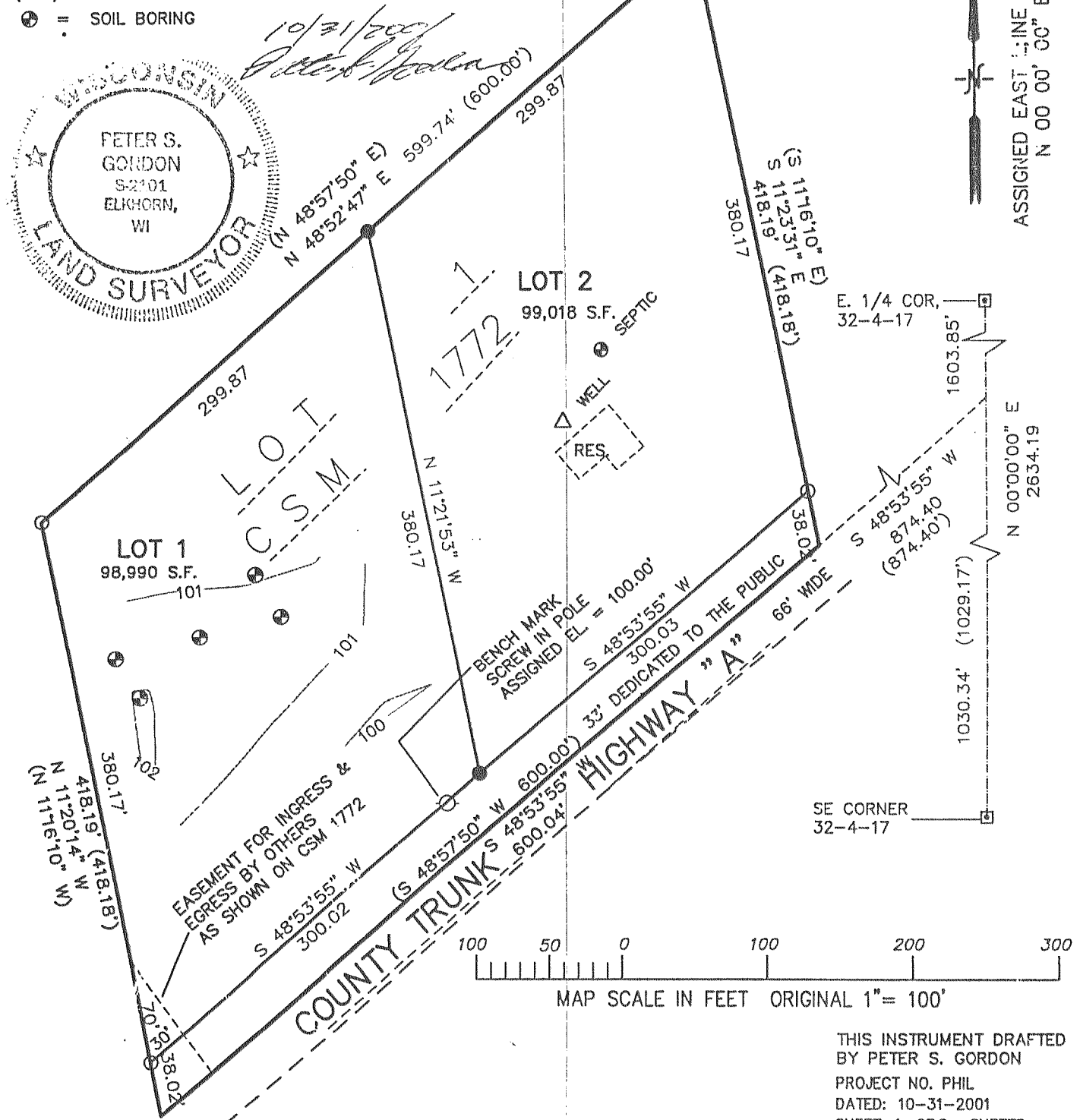

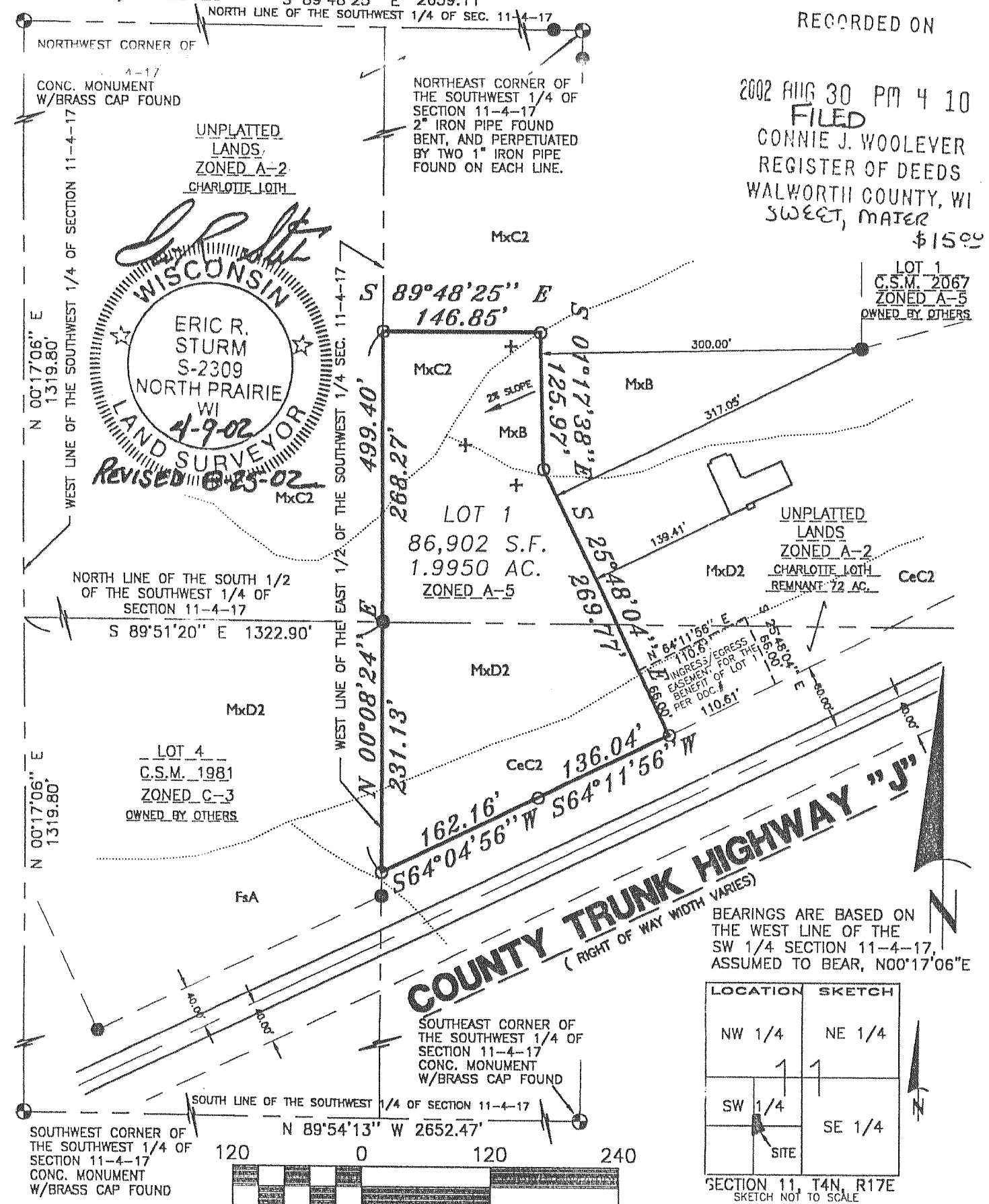

EAST, IN THE TOWN OF TROY, WALWORTH COUNTY, WISCONSIN.

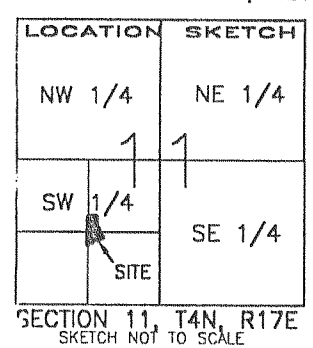
