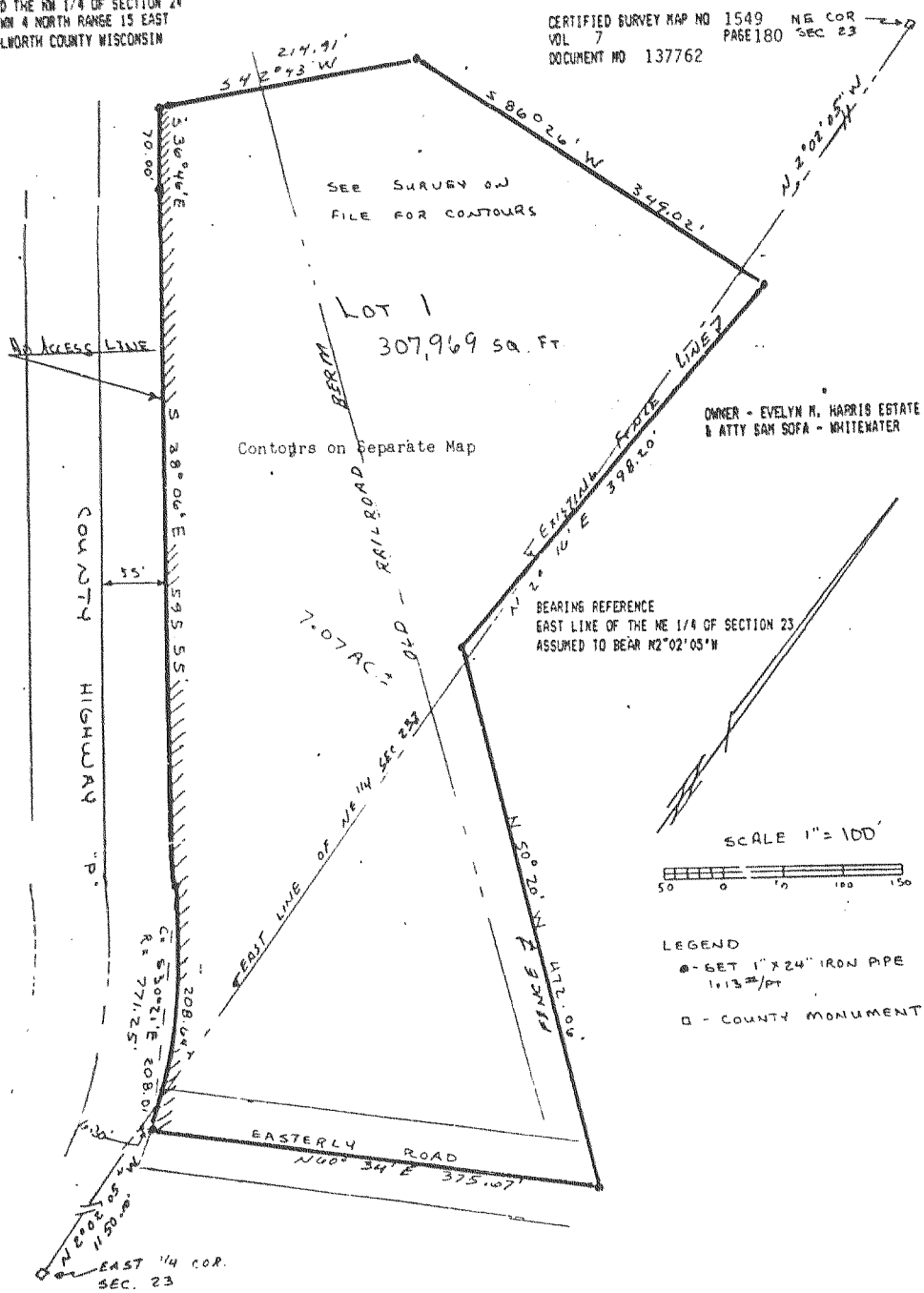

WALWORTH COUNTY WISCONSIN

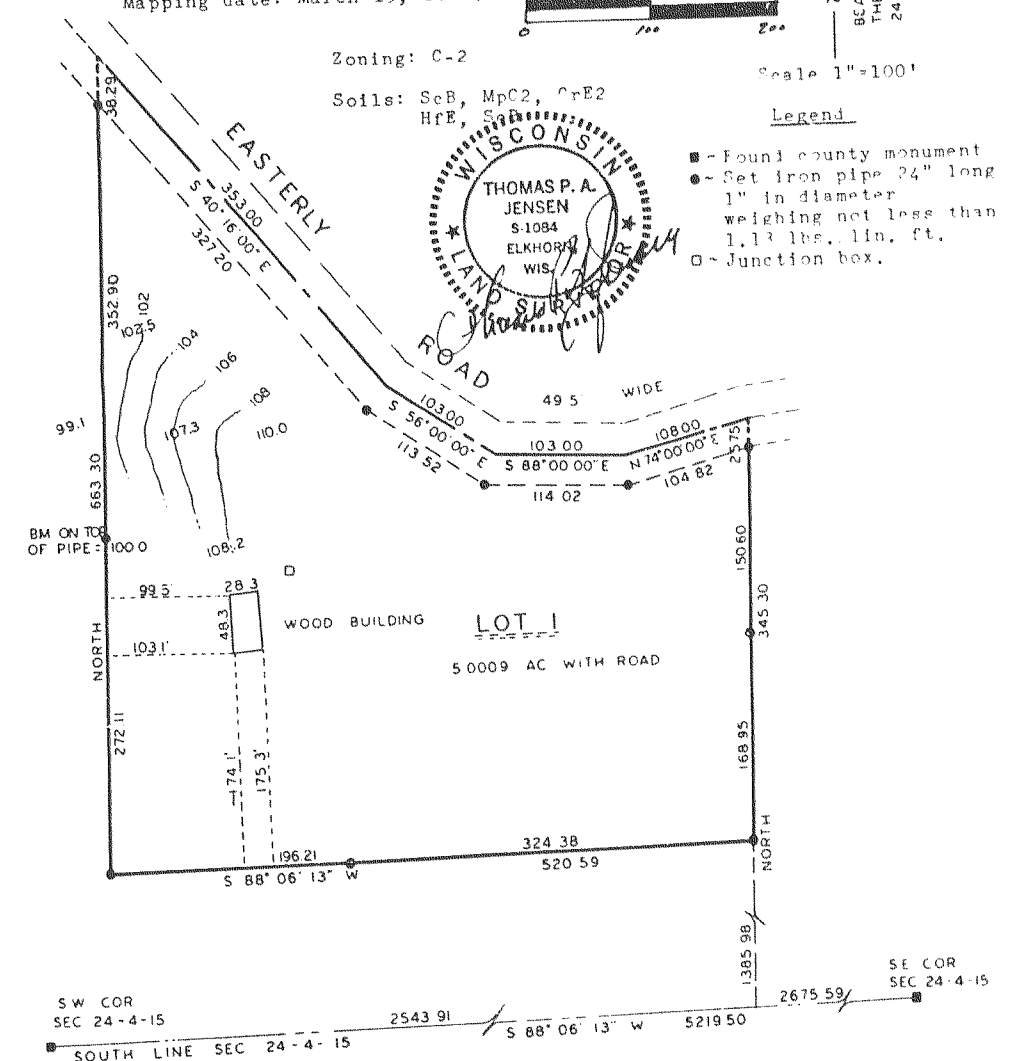

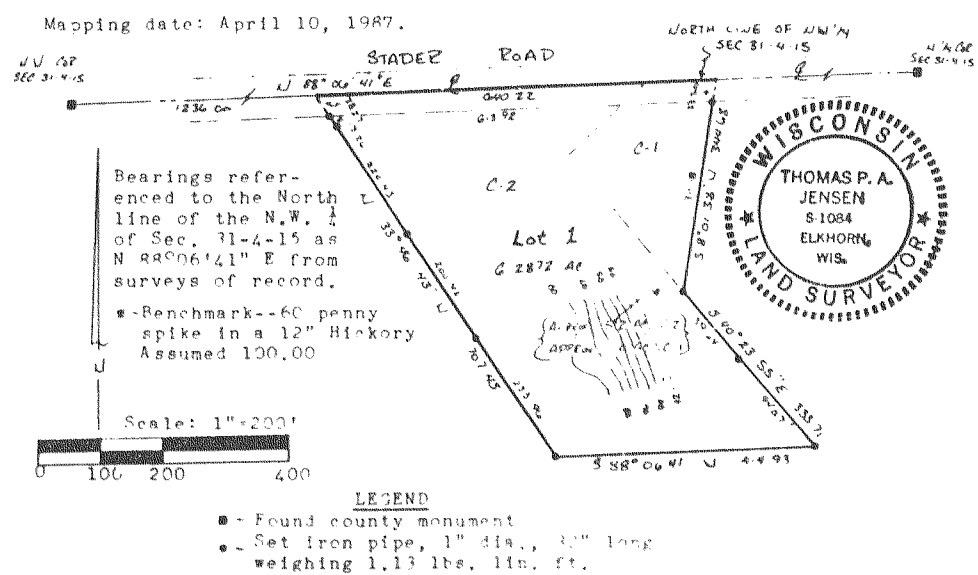
