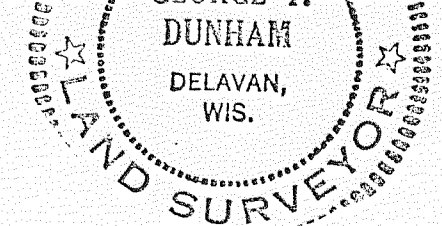


**SURVEYOR'S CERTIFICATE**

I, George T. Dunham, surveyor, hereby certify: That I have surveyed, divided, and mapped the land shown on the above plat and located in the N½ of the SW¼ of Sec. 5, T4N, R15E, City of Whitewater, Walworth County, Wisconsin, described as follows, to-wit: Commencing at the NE corner of the said SW¼; thence South 297.20 feet; thence S87°-52'W 330.00 feet to the place of beginning; thence South 213.23 feet; thence S87°-52'W 815.36 feet; thence S88°-03'W 240.00 feet; thence N0°-56'E 146.69 feet; thence S87°-52'W 198.25 feet to the W line of Elizabeth St.; thence N0°-56'E 66.09 feet to the SW Corner of Lot 14, Lawndale; thence N87°-52'E along the S line of Lawndale and the E'ly extension of said line 1213.80 feet to the place of beginning. **CORPORATION OWNER'S CERTIFICATE OF DEDICATION**

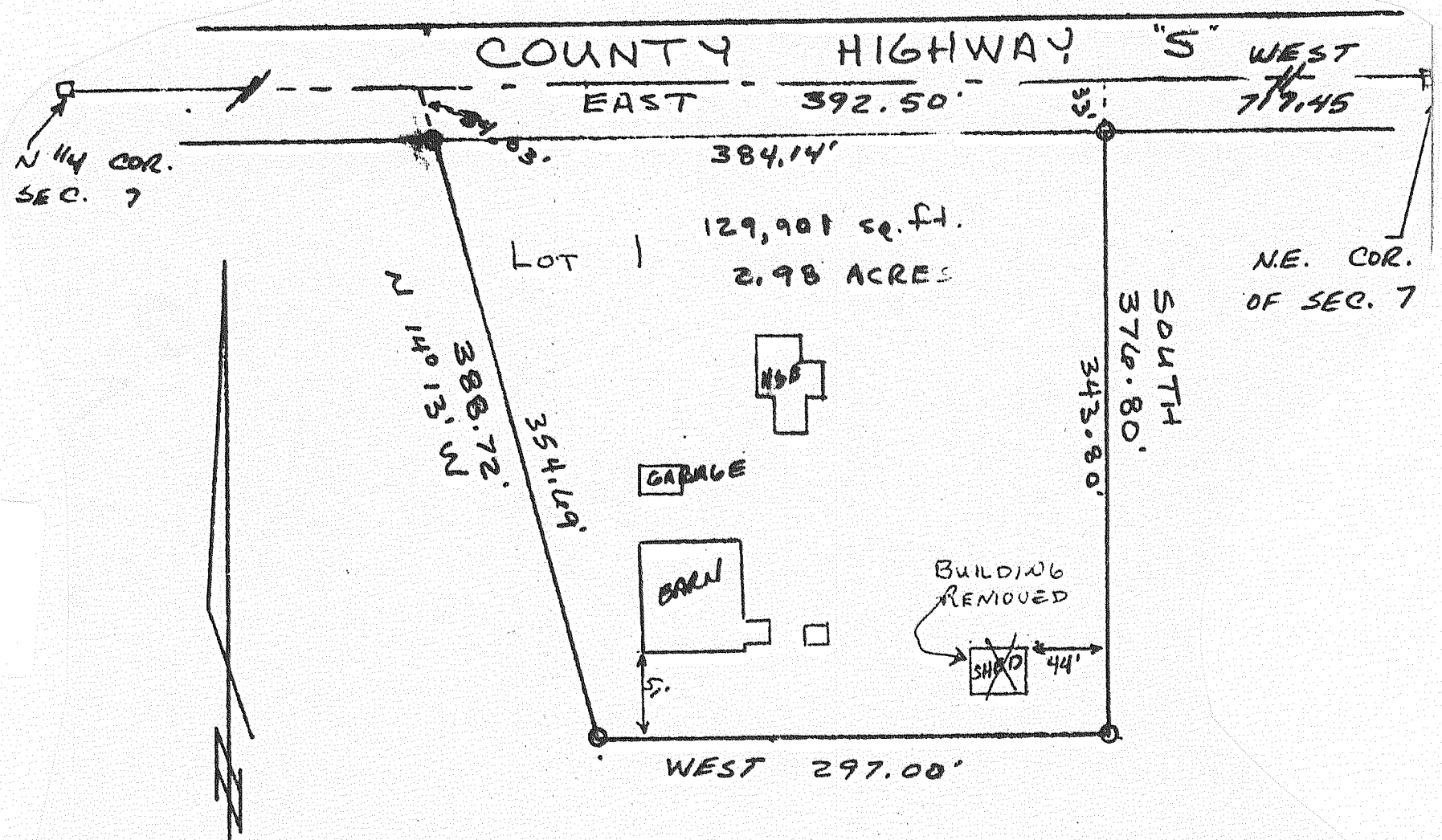

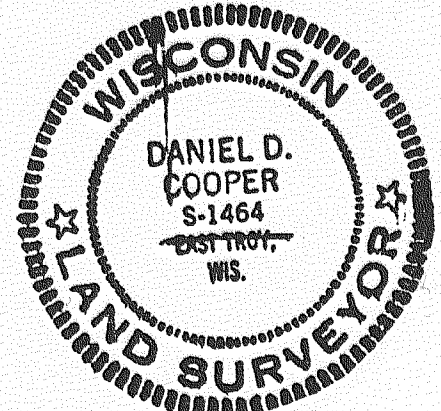
