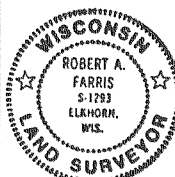
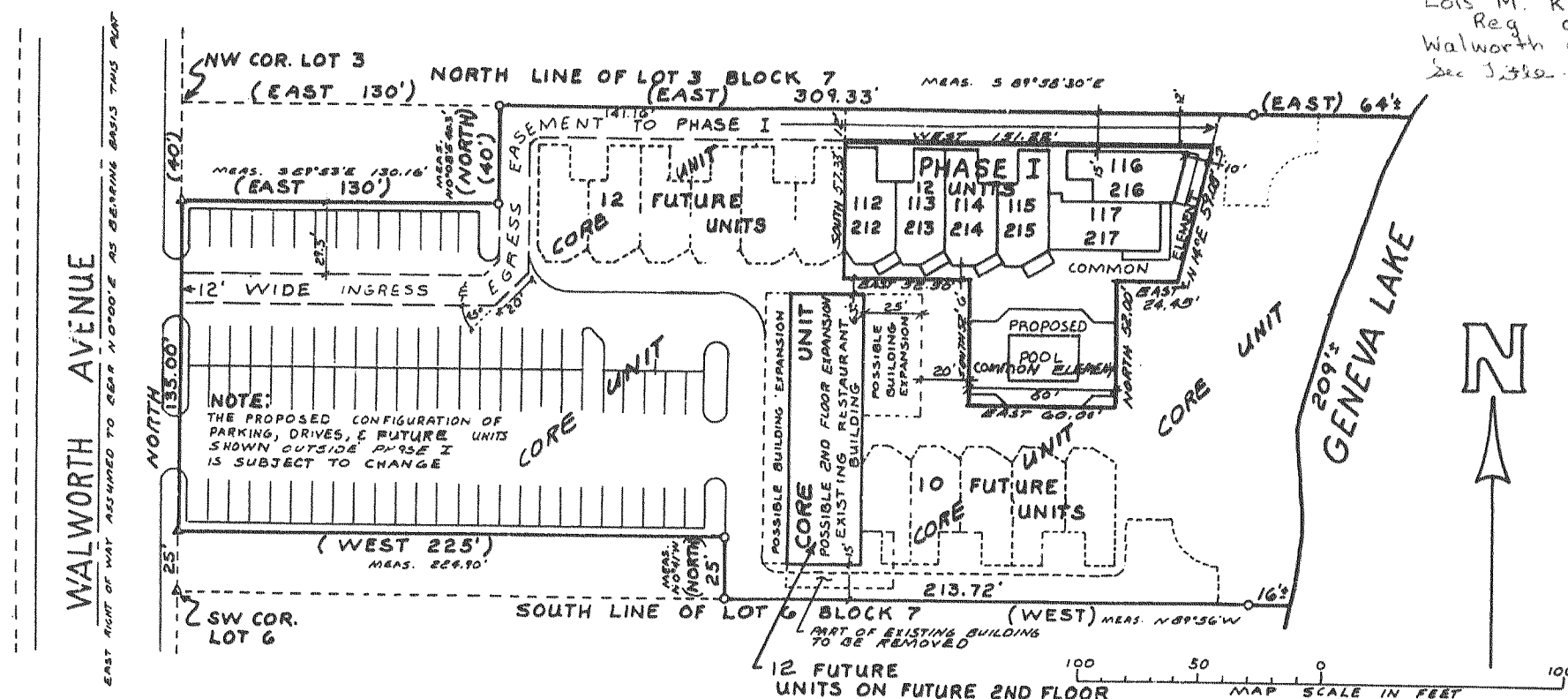

**LEGAL DESCRIPTION OF AREA SHOWN AS PHASE I**

Part of Lots 3 & 4 of Block 7 of the Original Plat of the Village of Williams Bay, Walworth County, Wisconsin bounded and described as follows:

Commencing at an iron pipe stake found in the North line of Lot 3 in said Block 7 at a point recorded as being 130 feet East of the Northwest corner of said Lot 3; thence East in said North line 141.16 feet; thence South 12.00 feet to the point of beginning; thence continue South 57.33 feet; thence East 52.50 feet; thence South 52.00 feet; thence East 60.00 feet; thence North 52.00 feet; thence East 24.45 feet; thence N 14deg 00min E 59.08 feet; thence West 151.22 feet to the point of beginning, containing 0.26 acres of land more or less.

**LEGAL DESCRIPTION OF BAY SHORE RESORT CONDOMINIUM**

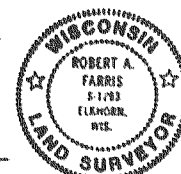
Part of Lots 3, 4, 5, and 6 of Block 7 of the Original Plat of the Village of Williams Bay, Walworth County, Wisconsin bounded and described as follows:

Commencing at an iron pipe stake found marking the Southwest corner of said Lot 6; thence North 25.00 feet in the East line of Walworth Avenue to a cross cut in concrete marking the point of beginning; thence continue North 135.00 feet in said East line to a cross cut in concrete recorded as being located 40 feet South of the Northwest corner of Lot 3 in said Block 7; thence East 130 feet to an iron pipe stake; thence North 40 feet to an iron pipe stake in the North line of Lot 3 in said Block 7; thence East in said North line 309.33 feet to an iron pipe stake in said North line; thence continue East 64 feet more or less in said North line to the shore of Geneva Lake; thence Southerly along said shore 209 feet more or less to the South line of Lot 6 in said Block 7; thence West in said South line 16 feet more or less to an iron pipe stake; thence continue West in said South line 213.72 feet to an iron pipe stake recorded as being located 225 feet East of the Southwest corner of said Lot 6; thence North 25 feet to an iron pipe stake; thence West 225 feet to the point of beginning, containing 1.92 acres of land more or less.

I hereby certify that Bay Shore Resort Condominium has been surveyed under my direction and that this plat is a correct representation of the condominium described and that the identification and location of each unit and the common elements can be determined from the plat.
