

PLAT OF SURVEY OF

A STRIP OF LAND LOCATED IN THE SOUTHEAST 1/4 OF THE SOUTHWEST 1/4 OF THE SOUTHEAST 1/4 OF SECTION 27, T2N,RI5E, WALWORTH COUNTY, WISCONSIN AND DESCRIBED AS FOLLOWS: COMMENCING AT AN IRON STAKE IN THE EASTERLY LINE OF THE CHICAGO AND MADISON ROAD. (NOW KNOWN AS STATE TRUNK HIGHWAY #89), 1020.2 FEET. S 48°30' E FROM THE SOUTHWEST CORNER OF THE PUBLIC SQUARE: THENCE S 48°30' E ALONG THE EASTERLY LINE OF SAID HIGHWAY 123 1/2 FEET TO AN IRON STAKE: THENCE N 41°30'E 122 FEET TO AN IRON STAKE: THENCE N 48°30' W 123 1/2 FEET TO AN IRON STAKE; THENCE S 41°30' W 122 FEET TO THE PLACE OF BEGINNING: ALSO THE FOLLOWING DESCRIBED PIECE OR PARCEL OF LAND ADJOINING THE PIECE OR PARCEL AFOREDESCRIBED AS FOLLOWS: COMMENCING AT THE PLACE OF BEGINNING OF THE PARCEL AFOREDESCRIBED AND CONTINUING IN A STRAIGHT LINE, THE LINE LAST AFOREDESCRIBED, 33 FEET TO THE CENTER OF THE CHICAGO AND MADISON ROAD (NOW KNOWN AS STATE TRUNK HIGHWAY #89); THENCE \$ 48°30' E ALONG THE CENTERLINE OF SAID ROAD 123 1/2 FEET: THENCE N 41°30' E 33 FEET TO AN IRON STAKE ON THE EASTERLY LINE OF SAID HIGHWAY: THENCE NORTHWESTERLY ALONG THE EASTERLY LINE OF SAID HIGHWAY ON A LINE PARALLEL TO THE CENTER OF THE SAID CHICAGO AND MADISON ROAD 123 1/2 FEET TO THE PLACE OF BEGINNING. THE ABOVE LANDS NOW LOCATED IN THE VILLAGE OF DARIEN.
