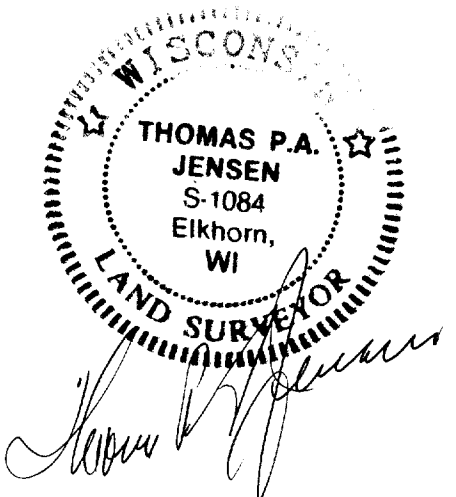
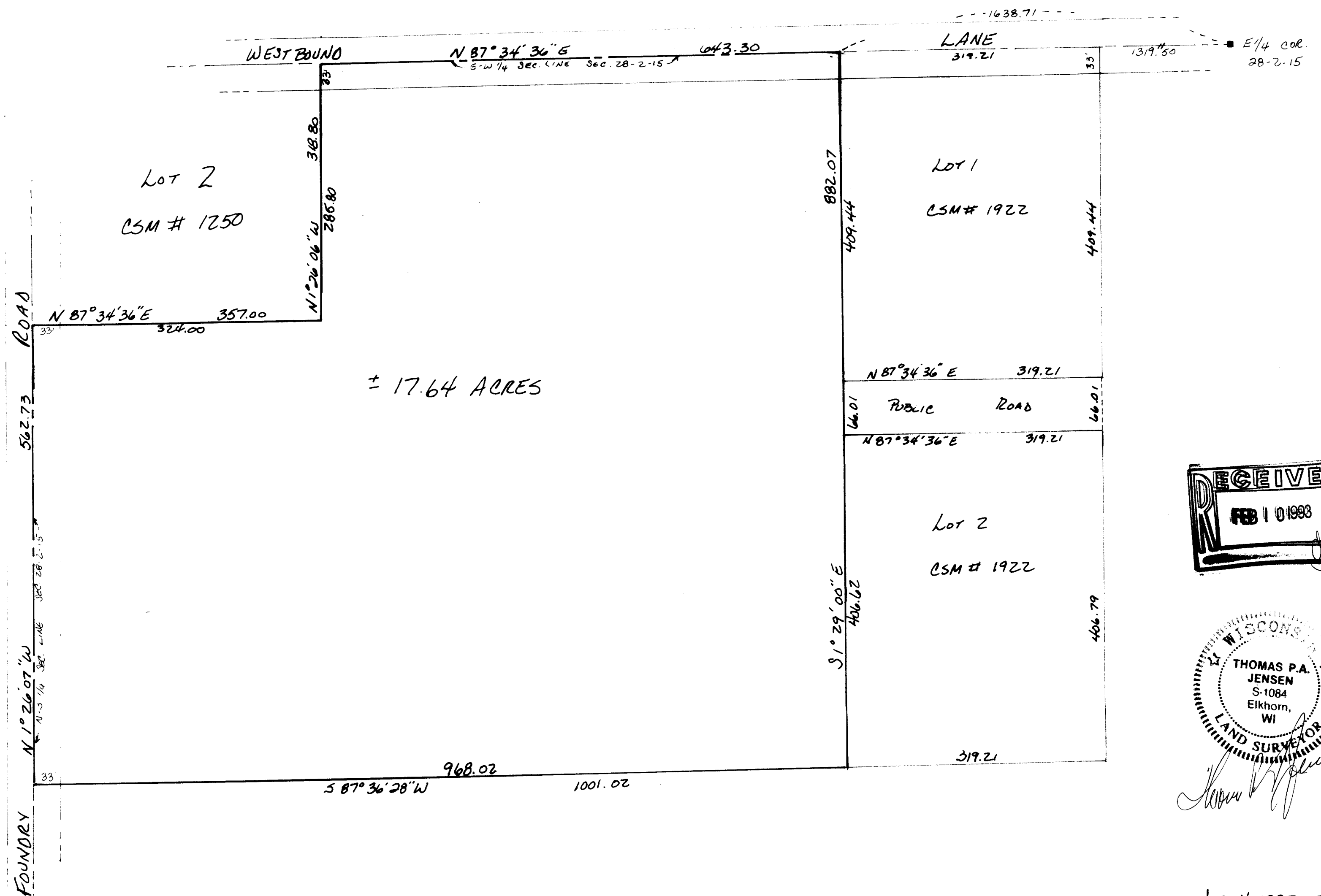



AN ORDINANCE ANNEXING CERTAIN LANDS
IN THE TOWNSHIP OF DARIEN TO THE
VILLAGE OF DARIEN, WALWORTH COUNTY

Pelishek-Lawton Annexation


The Village Board of the Village of Darien, Walworth County, Wisconsin, does ordain as follows:

Section 1. That the following described parcel of land owned by Gerald Pelishek and Fred Lawton, which is located in the Town of Darien, be and the same is hereby annexed into the corporate limits of the Village of Darien.

A parcel of land located in the Southeast 1/4 of Section 28, Town 2 North, Range 15 East, Town of Darien, Walworth County, Wisconsin, described as follows: Commencing at the East 1/4 corner of Said Section 28; thence S 87°34'36" W, along the E-W 1/4 section line and also the centerline of Westbound Lane, 1638.71 feet to the Northwest Corner of Certified Survey Map No. 1922 and the Point of Beginning; thence S 1°29'00" E, along the west line of C.S.M. #1922, 882.07 feet to the Southwest corner of C.S.M. #1922; thence S 87°36'28" W 1001.02 feet; to the N-S 1/4 Section line and also the Centerline of Foundry Road; thence N 01°26'07" W, along the N-S 1/4 section line, 562.73 feet to the southwest corner of C.S.M. #1250; thence N 87°34'36" E, along the south line of C.S.M. #1250, 357.00 feet to the southeast corner of C.S.M. #1250; thence N 01°26'06" W, along the east line of C.S.M. #1250, 318.80 feet to the E-W 1/4 section and also the centerline of Westbound Lane; thence N 87°34'36" E, along the E-W 1/4 section line, 643.30 feet to the Point of Beginning. Said parcel contains 17.64 acres of land, more or less.

Section 2. The aforesaid parcel shall be zoned M-1, Limited Manufacturing District.
