

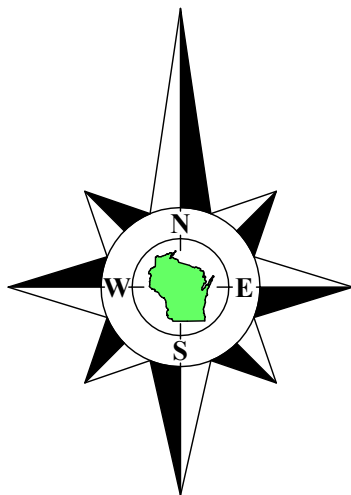

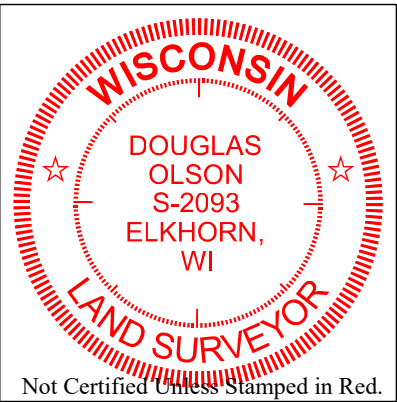
## Lot 51 of The Ponds of Darien,

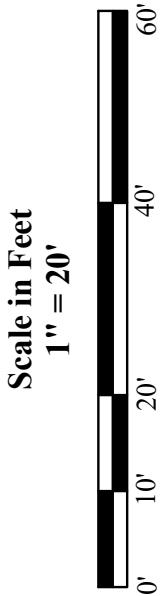
