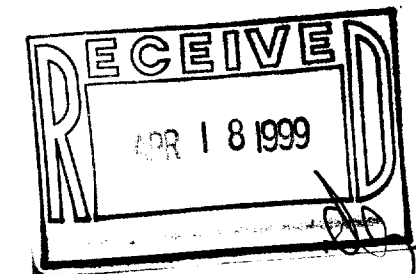


Beginning at a point on the N. line of Walworth Avenue, in the City of Delavan, 44 ft. E. of the S.E. corner of Lot 5 in Block 10 of the Original Plat of the Village, now City of Delavan; run thence N. 162.12 ft; thence W. at right angles 44 ft. to the E. line of said Block 10; thence S. along the E. line of said Block 10, 46.32 ft.; thence E. at right angles 22 ft. and 3 inches to a point in the center of the brick wall between the store buildings; thence S. along the center of the brick wall 115.8 ft. to the N. line of Walworth Avenue; thence E. along the N. line of Walworth Avenue 21 ft. and 9 inches to the place of beginning. Also a right of way over and across the following described lands: Beginning at a point on the W. line of the above premises which is 115 ft. N. of the N. line of Walworth Avenue; thence W. 46 ft. 3 inches; thence S. 15 ft.; thence E. 46 ft. 3 inches and thence N. 15 ft. to the place of beginning.
