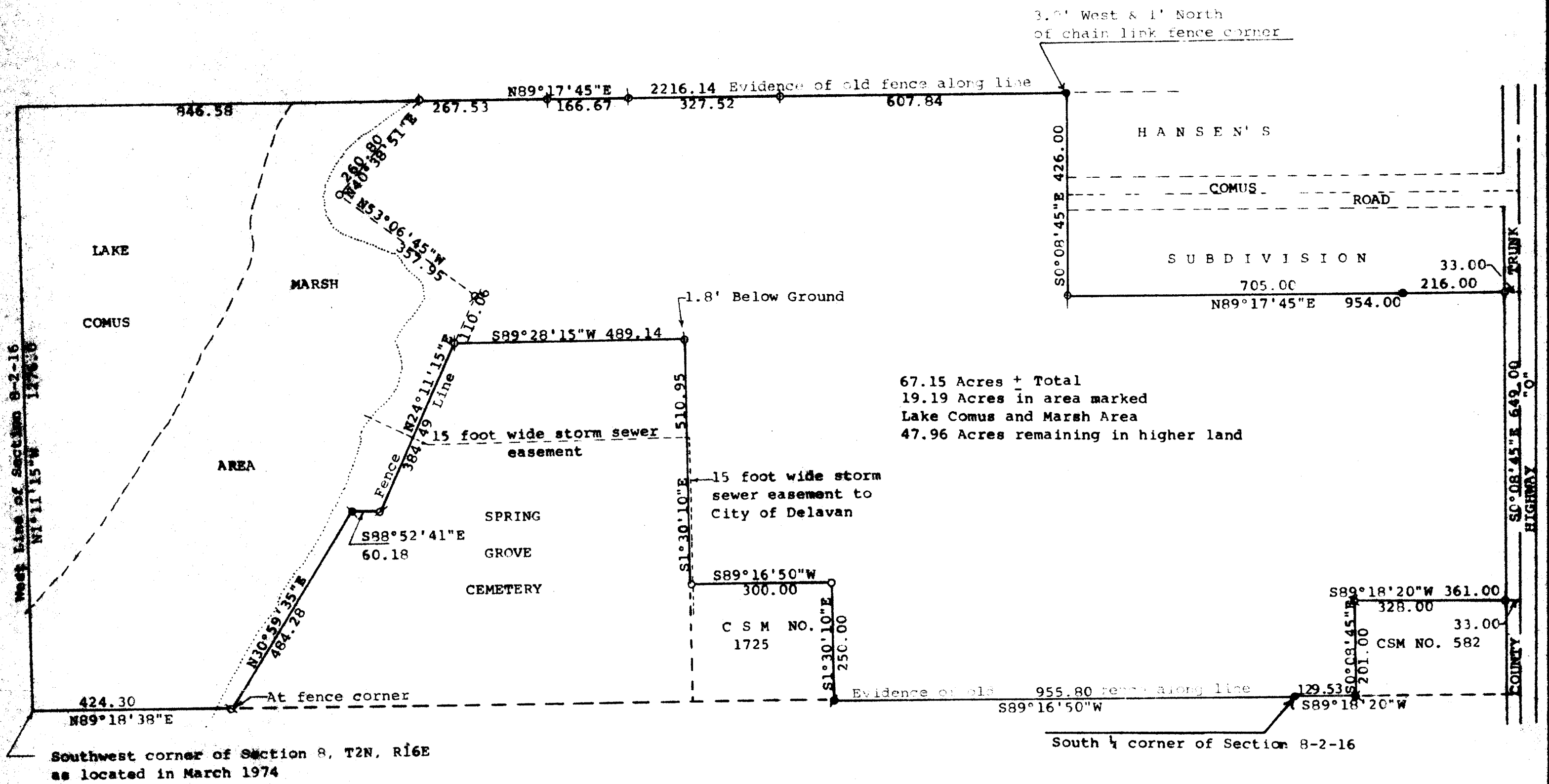

Kiess, as prepared from various field surveys made by Dunham Surveying, SC, Abell Surveying & Mapping, Kolb Land Consulting, Inc and from the City of Delavan, from 1974 to the present date and not from a field survey made at the present date, said land is described as follows: A parcel of land located in the Southwest 1/4 and in the Southwest 1/4 of the Southeast 1/4 of Section 8, T2N, R16E, City of Delavan, Walworth County, Wisconsin, described as follows: Beginning at the South 1/4 corner of said Section 8; thence S89°16'50"W 955.80 feet to the southeast corner of Certified Survey No. 1725; thence N1°30'10"W along said certified survey 250.00 feet; thence S89°16'50"W 300.00 feet to the northwest corner of said certified survey; thence N1°30'10"W 510.95 feet; thence S89°28'15"W 489.14 feet; thence S24°11'15"W 384.49 feet; thence N88°52'41"E 60.18 feet; thence S30°59'35"W 484.28 feet to the south line of said Section 8; thence S89°18'38"W 424.30 feet to the southwest corner of said Section 8; thence N1°11'15"W along the west line of said section 1276.00 feet; thence N89°17'45"E 2216.14 feet to the northwest corner of Hansen's Subdivision; thence S0°08'45"E along said Hansen's Subdivision 426.00 feet; thence N89°17'45"E along said Hansen's Subdivision 954.00 feet to the centerline of County Trunk Highway "O"; thence S0°08'45"E along said centerline 649.00 feet to the northeast corner of Certified Survey No. 582; thence S89°18'20"W 361.00 feet to the northwest corner of said Certified Survey No. 582; thence S0°08'45"E 201.00 feet to the southwest corner of said certified survey; thence S89°18'20"W along the south line of said Section 8, 129.53 feet to the place of beginning containing 67.15 acres of land more or less.

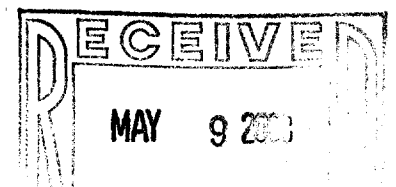

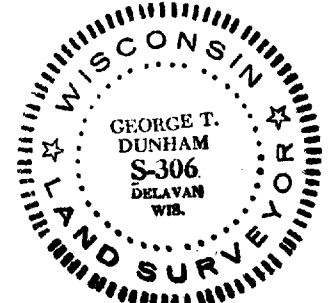
