PART OF THE SOUTHWEST 1/4 OF SECTION 18, TOWNSHIP 2 NORTH, RANGE 16 EAST, CITY OF DELAVAN, WALWORTH COUNTY, WISCONSIN, DESCRIBED AS FOLLOWS: BEGINNING AT A POINT IN THE CENTER OF BELOIT STREET IN SECTION 18, IN THE CITY OF DELAVAN, WALWORTH COUNTY, WISCONSIN, WHICH POINT IS THE SOUTHWEST CORNER OF LANDS DEEDED BY A.H. KENDRICK AND WIFE TO A.H. BARNES THE 19TH DAY OF JANUARY, 1888, AND WHICH DEED IS ON RECORD IN THE REGISTER OF DEEDS OFFICE IN AND FOR WALWORTH COUNTY, WISCONSIN IN VOLUME 78 OF DEEDS, PAGE 12, AND WHICH PLACE OF BEGINNING IS ALSO THE POINT WHERE THE CENTER OF SAID BELOIT STREET INTERSECTS THE NORTH LINE OF LANDS FORMERLY OWNED BY ELLEN W. PHOENIX; THENCE EAST ALONG THE NORTH LINE OF LANDS OF SAID PHOENIX, AND BEING ALSO THE SOUTH LINE OF SAID BARNES LAND, 1282 FEET TO A STAKE; THENCE NORTH AT RIGHT ANGLES TO SAID LAST MENTIONED LINE 175.5 FEET TO A STAKE; THENCE WEST PARALLEL WITH THE FIRST MENTIONED LINE RUNNING EAST 1200 FEET TO THE CENTER OF SAID BELOIT STREET; THENCE SOUTHWEST ALONG THE CENTER OF SAID STREET TO THE PLACE OF BEGINNING. 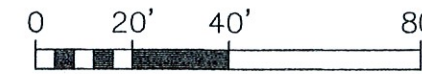

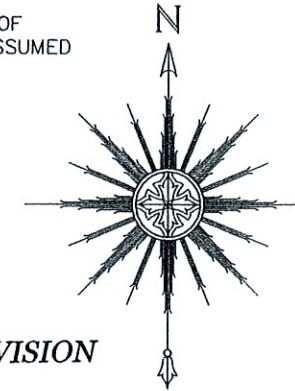

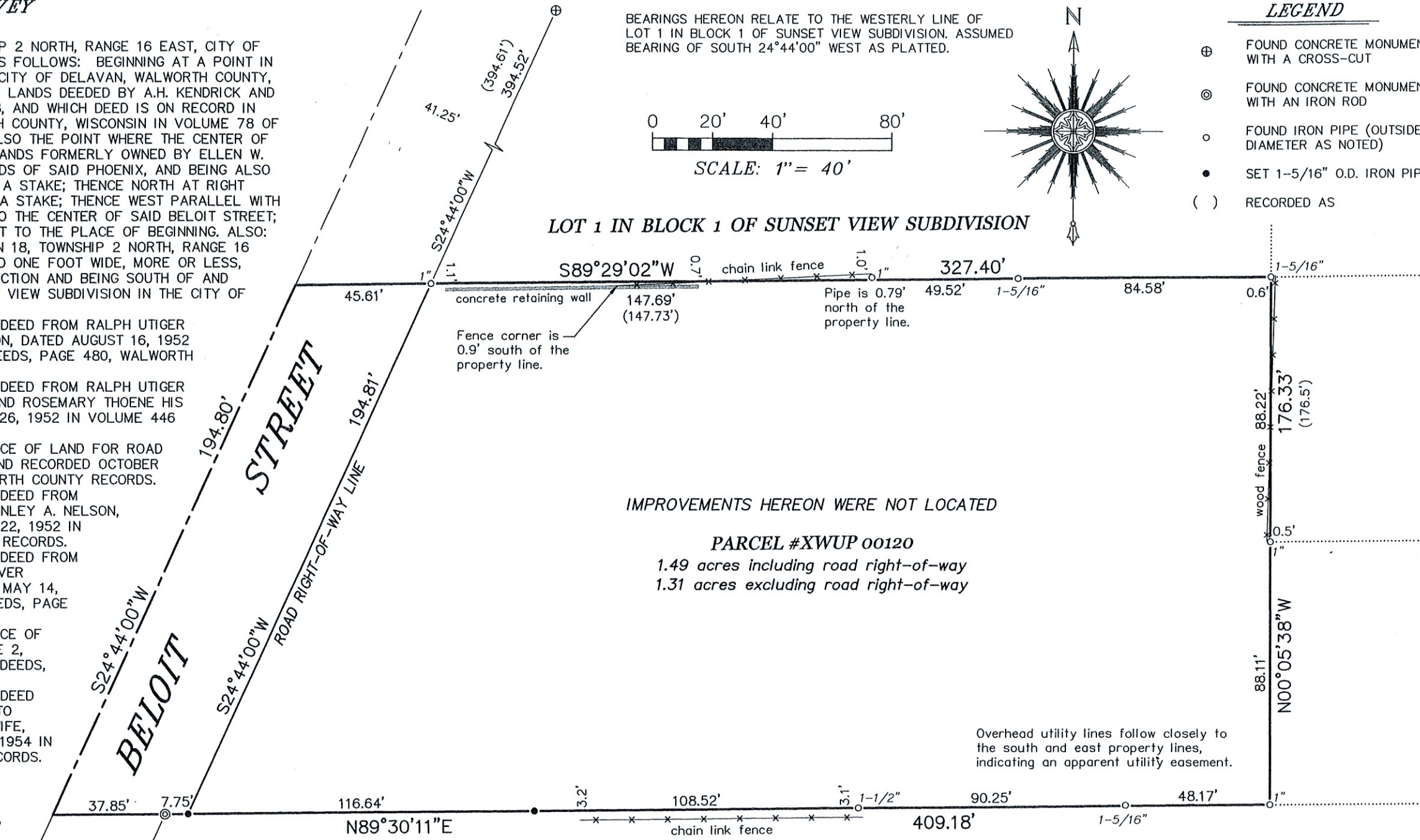

Overhead utility lines follow closely to the south and east property lines, indicating an apparent utility easement.

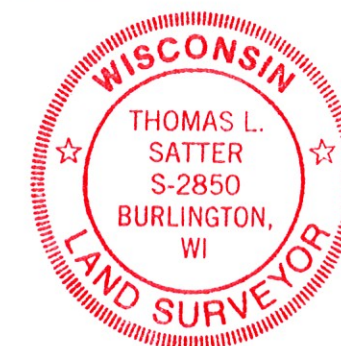
