Phoenix Addition to the City of Delavan; thence N89°25'E along the south line of said Block 1, 119.21 feet to the west line of Fifth Street; thence S0°02'20"W along the west line of Fifth Street 77.00 feet to the northeast corner of said Lot 4, Knapp's Subdivision; thence northeast corner of said Lot 4, Knapp's Subdivision; thence S89°26'W 119.45 feet to the place of beginning, subject to the rights of others over and along the northerly 11.00 feet of the above described land for use as an alley.
