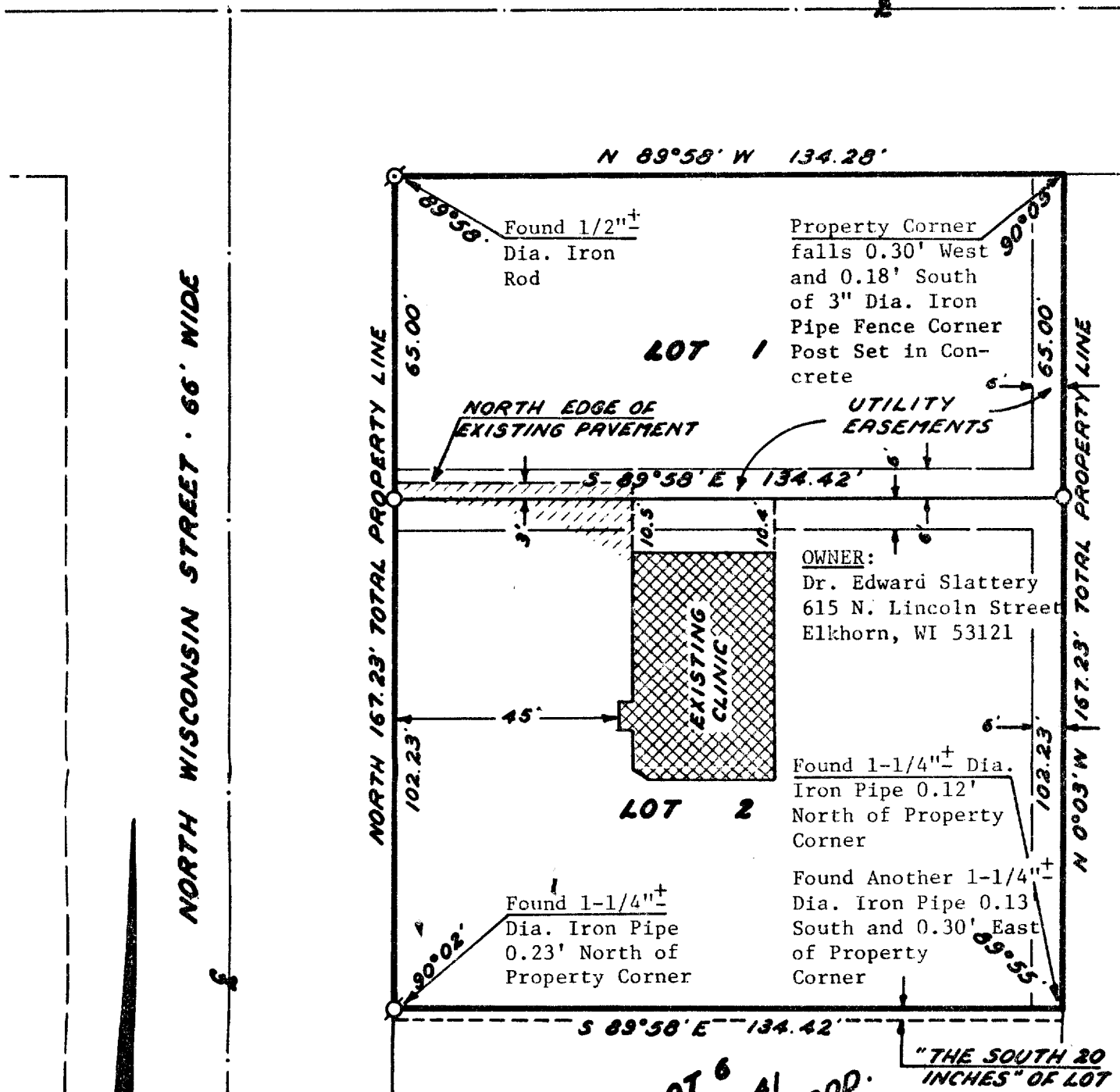

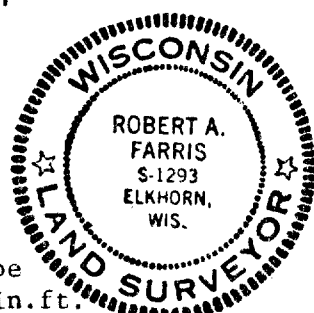
A DIVISION OF LOT 2 AND PART OF LOT 3 IN BLOCK 41 OF DAVIS ADDITION, LOCATED

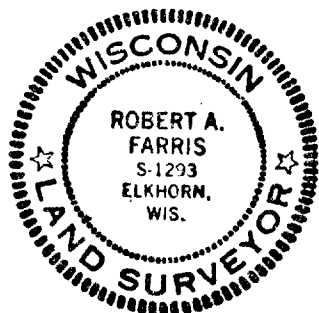

SURVEYOR'S CERTIFICATE

I, Robert A. Farris, registered land surveyor, do hereby certify that at the direction of Dr. Edward Slattery, owner, and in full compliance with the provisions of Chapter 236.34 of the Wisconsin Statutes and the Land Division Ordinance for the City of Elkhorn, I have surveyed, mapped and divided the following described parcel as recorded in Volume 663, Page 650 of Deeds, Walworth County, Wisconsin:

"Lots 2 and 3 in Block 41 of Davis Addition to the City of Elkhorn, Walworth County, Wisconsin, excepting therefrom a strip of land 20 inches in width off the South side of said Lot 3 Block 41 Davis Addition;" more particularly described as follows:

Beginning at the Northwest corner of Block 41 of Davis Addition to the City of Elkhorn; thence South 167.23 feet along the Easterly right-of-way line of North Wisconsin Street; thence S 89°58' E 134.42 feet; thence N 0°03' W 167.23 feet to the Southerly right-of-way line of Second Avenue; thence N 89°58' W 134.28 feet along said Southerly right-of-way line to the place of beginning.
