WALWORTH COUNTY, WISCONSIN.

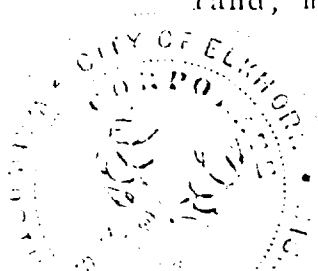
The Common Council of the City of Elkhorn, Wisconsin, does
