PARCELS OF LAND LOCATED IN LOTS 6 AND 7, BLOCK 5 OF ARNOLD'S ADDITION TO THE VILLAGE (NOW CITY) OF ELKHORN, LOCATED IN THE SOUTHWEST 1/4 OF SECTION 31, T 3 N, R 17 E, WALWORTH COUNTY, WISCONSIN, DESCRIBED AS FOLLOWS:

PARCEL 1: COMMENCING AT THE SOUTHWEST CORNER OF SAID LOT 6, THENCE S84°08'15"E ALONG THE NORTHERLY LINE OF EAST GENEVA STREET 51.58 FEET TO THE PLACE OF BEGINNING; THENCE N33°14'25"E 212.25 FEET; THENCE N34°39'15"E 208.57 FEET; THENCE N39°54'50"W 17.58 FEET; THENCE N34°26'15"E 26.67 FEET; THENCE S55°24'00"E 99.79 FEET; THENCE S34°27'15"W 54.65 FEET; THENCE N39°19'35"W 17.59 FEET; THENCE S34°14'25"W 295.47 FEET TO THE NORTHERLY LINE OF EAST GENEVA STREET; THENCE N89°16'10"W ALONG SAID NORTHERLY LINE 24.54 FEET; THENCE N84°08'15"W ALONG SAID NORTHERLY LINE 48.03 FEET TO THE PLACE OF BEGINNING.
